

DIRECTIONS TO DEMERY FARM

Directions to the site: From I-94 (west of Ann Arbor), take exit 167 (Baker Road, Dexter exit). At the bottom of the exit ramp, turn left (south) and go a short distance to Jackson Road (at the traffic light) and turn right (west). Continue on Jackson Road 1 mile, to the traffic light. Turn left (south) on Parker Road and go 6 miles. Road will curve to the right (west) and become Pleasant Lake Road. Stay on Pleasant Lake Road heading west for 2 miles to Schneider Road. (Do not turn left at the Parker Road sign). Turn left at Schneider Road. Go 1 mile and turn right at the second gravel road, Koebbe. Site is 1/2 mile on the right.

Directions to Frankenmuth:

Frankenmuth is approx. 1 hour & 35 minutes, 93 miles north of the coursing field. From the trial site, go back to I-94, exit 167. Go east 4 miles on I-94, to exit 171 (which is a left exit), & exit on M-14. Go 4 miles on M-14. From the left lane merge onto US-23 north (Brighton/Flint). US-23N will merge with I-75 near Flint. Continue on I-75 north to exit 136 (M-54/M-83 Birch Run exit). Go right (east) & follow M-83, 6 miles to Frankenmuth.

ELIGIBILITY

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered hounds are eligible. Monorchid & cryptorchid dogs are NOT eligible. Bitches in-season and lame hounds will be excused and entry fees refunded. Owners may NOT substitute for lame or in-season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

TEST OFFERED

Junior Courser (JC) - Two Tests Offered: Open to all eligible Borzoi. A hound running alone shall receive a certificate from a judge on one date, and a second certification from a different judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. Hound must complete the course with enthusiasm and without interruption. The two runs can be run on the same date at or in conjunction with a National Breed Specialty

A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress.

A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips.

BCOA reserves the right to alter the course plan if required by weather and/or field conditions prior to or on the day of the trial, which may affect the usability of the field. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, will forfeit entry fee(s), and may be disciplined by the AKC.
