

## Region 1 - Rebecca Peters-Campbell

I became the Region I Governor after the resignation of the duly elected governor, Maureen Bardwell, PhD, due to her relocation to an area outside this region. On behalf of BCOA members in Region I, I'd like to thank Maureen for her many years of faithful service and wish her all the best in her new home.

The 4 borzoi clubs in Region I have lots of plans for 2006. Anybody who is interested in any of these activities is welcome to contact me for full particulars.

On <u>Friday, May 5</u>, the Borzoi Club of Greater New York (BCGNY) will hold their Spring Specialty in *Ringwood, NJ*. The show has an entry of 107 Borzois, with a total entry of 153, including 2 Obedience entries and 11 Rally entries. Sweepstakes will be judged by Mrs. Mary Moran-Richter, and the regular classes will be judged by Mr. Frederick Dewsbury (Canada). Mr. George Mallow will judge obedience, and Mrs. Elizabeth Elvidge will judge rally.

Two days later, on <u>Sunday May 7</u>, the Borzoi Club of the Delaware Valley (BCDV) is holding their Spring Specialty in conjunction with the Trenton KC all-breed show. They also have an excellent entry – 115 borzois (sweepstakes and obedience entries are not yet available). Regular classes will be judged by Mr. Thomas Kirstein, and Sweepstakes will be judged by Ms. Karen Murray. The Potomac Valley Drill Team will delight spectators with a performance during the show. Additionally, BCDV will host a summer picnic – time & place to be announced later.

The Borzoi Club of Central New Jersey (BCCNJ) is holding a fun match on <u>Sunday June 25</u>, at the home of Roni & Jennifer Zucker in *Moscow PA*.

On <u>Sunday, July 23</u>, BCCNJ will be supporting the borzoi entry at the Hudson River Valley Hound Show in Chatham NY. Judge information is not yet available for these events. On the days before the HRV Hound Show, the Putnam KC will hold shows in nearby Stormville, NY. On Friday borzois and the Hound group will be judged by Ms. Carol Reisman, and on Saturday borzois and the Hound group will be judged by Mrs. Sari Brewster Tietjen.

September is going to be an incredibly busy month in the Northeast. The first series of shows will be held in *North Branch*, *NJ*.

On <u>Thursday, Sept. 7</u>, the Central New Jersey Hound Association will hold their show, with Mr. Kent Delaney judging breed, and Mrs. Nadine Johnson judging the Hound group. The sweepstakes judge has not yet been confirmed.

On <u>Friday, Sept. 8</u>, BCGNY will hold a specialty show in conjunction with the Tuxedo Park KC all-breed show, with Mr. Louis Auslander judging the regular classes and Ms. Eileen Flanagan judging sweepstakes. The Hound Group will be judge by Mr. Lester Mapes.

On <u>Saturday</u>, <u>Sept. 9</u>, BCCNJ will hold a specialty show in conjunction with the Somerset Hills KC allbreed show, with Mrs. Gayle Bontecou judging breed and Mr. Kent Delaney judging the Hound Group. The sweepstakes judge is pending.

The next weekend, borzoi events move to the 4-day show circuit in Falmouth, MA.

On <u>Saturday, Sept.</u> 16, the Borzoi Club of New England (BCNE) will support the entry at the South Shore KC all-breed show, with Mr. Raymond Filburn, Jr., judging the regular classes and Mr. Terry Clements judging Sweepstakes. Mr. Charles Olvis will judge the Hound group.

On <u>Sunday, Sept. 17</u>, BCNE will host a specialty show in conjunction with the Cape Cod KC all-breed show, with Ms. Carol Reisman judging the regular classes & the Hound Group, and Mr. Michael Work judging sweepstakes.

For anybody interested in attending all 4 days of shows, at the Cape Cod KC show on Thursday, borzoi will be judged by Mr. Merlin J Van De Kinder (Canada) and Mr. Filburn will judge the Hound group. On Friday at the South Shore KC show, Mr Olvis will judge borzoi and Mr. Douglas Windsor will judge the Hound group.

On <u>Sunday, Sept. 24</u>, BCNE will support the entry at Northwestern CT KC's all-breed show in Goshen, CT. The regular class judge is not yet posted; Eileen Ketcham will judge sweepstakes.

BCNE also intends to host a specialty show during the Thanksgiving circuit in W. Springfield, MA. Linda Deutsch is scheduled to judge sweepstakes.

In addition to all these plans by clubs, BCOA members and other borzoi lovers in Region I will be working to prepare for the 2007 National Specialty Show, to be held at the Crowne Plaza Hotel, in Warwick, RI. The tentative schedule calls for running events on the weekend of April 21 & 22, and BOB judging on Saturday, April 28. Pending AKC approval, we hope to host an all-breed agility trial on Thursday & Friday, April 19 & 20, right before the national.

Since the 10 days of events will include agility, conformation, lure coursing, rally, and racing, plus educational events and lots of great food and fun, there will be something for everyone. In preparation for hosting an agility trial in conjunction with our national specialty, pending approval we will be holding an Agility B Match on <u>Friday</u>, <u>October 20, 2006</u>, in conjunction with Cape Cod KC's 3-day agility trial in *Falmouth*, *MA*.
