## AKC Delegate - Barbara O'Neill

July 26, 2012

The AKC Delegate Meeting was held June 12 in Raleigh, NC. I was unable to attend.

At the June meeting, the biggest controversy concerns the new grooming space requirement with the opposition requesting the Board revisit the issue. Basically, the new rule requires that at least 50% of all grooming space be set aside for day grooming at no cost. It should not affect the BCOA as we always make sure that there is plenty of free grooming space for exhibitors. At its July meeting, the AKC Board did revise its policy on reserved grooming space and removed the 50% requirement. However, a club which does offer paid reserved grooming/crating space, shall submit with its application a plan detailing the paid and unpaid space. This plan is subject to AKC approval.

The proposed amendment to create a new three-point major for the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch at one National Specialty each year will be voted on at the September Delegate meeting.

There was discussion about the new judge options. A Parent Club may invite a non-approved Judge, with a history of prestige and quality in a breed, to judge a National Specialty or Regional Specialty, by invitation, and subsequent approval of the AKC.

The AKC Political Action Committee (AKC PAC) has sent a letter to Club Presidents, challenging them to secure at least \$200 for the PAC with 100% of contributions going to support dog-friendly candidates in critical races. Even a small donation to the AKC PAC would be appreciated.

Effective January 1, 2013, AKC will initiate a new Family Dog Program. This will include the recognition of Therapy Dog titles and a new suffix title "CGC" for dogs passing a Canine Good Citizen® test.
