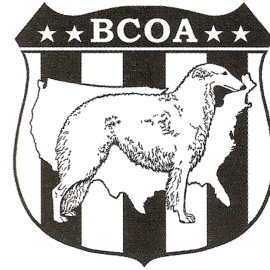


**BCOA Board Meeting**

\*Registry of Merit (Barb Ewing): KC Artley moved, seconded by Prudence Hlatky, to approve titles listed for dogs in this report. The motion carried.

\*Rescue (Dee Jones): In future, NBRF & BR-NC reports will be summarized for inclusion in BCOA Rescue report.

\*Sales (Carol Enz): A Garage Sale is scheduled for 2014 National Specialty. Bargains galore!

\*Standing Rules (KC Artley): To Clarify, Sweepstakes Rules apply only to puppy & veterans sweepstakes.

KC Artley moved, seconded by Barbara O'Neill that as a special attraction in 2014, the Dual Champion Sweeps will be governed by its own rules. The motion carried.

Implementation of Standing Rule: In order to implement the current standing rules, Barbara O'Neill volunteered to mail the champion medals to BCOA members whose dogs earn performance titles. To clarify, the medal is given for the first title earned in that activity. The list of dogs earning the AKC titles of CD, TD, FC and the first agility title, will be sent to Barbara from the electronic file provided by the AKC to BCOA. *The BCOA member must send Barbara O'Neill proof of the following non-AKC titles, in order to receive the champion medal: ASFA-FCH, LGRA-GRC, NOTRA-ORC, and the first open field title earned by the dogs from the TCC or NACA or NOFCA organizations.* Also note that a dog will only get a medal for his first lure coursing title, either the AKC-FC or the ASFA-FCH. This is retro-active to 1 January 2013."

### **Unfinished Business**

\*Website Update (RLynn Shell/ Joy Windle)

Barbara noted that BCOA was the first parent club to have a national website.

[www.borzoiclubofamerica.org](http://www.borzoiclubofamerica.org) has a new, fresh look. Although updating is an ongoing process, the content of the breed information documents should be completed by 1 January 2014. On the Board's behalf, Karen Mays will send a note of thanks and commendation to RLynn Shell.

\*Wolf hunting with dogs in Wisconsin: At the request of members in Region 6, the board revisited the Wolf Hunting issue. Prior to the board meeting the regional governors had polled members in their regions on the issue. Based on feedback from the BCOA membership national wide the BOD elects to make no changes to it previously stated position.

\*Borzoi Health and Welfare Foundation Proposal (Prudence Hlatky)

Prudence explained the rationale for the proposal: Members have indicated that they would be more likely to make bequests to Borzoi if those donations & bequests were tax exempt. This proposal would provide tax-exempt beneficiary of donations (cash and kind) with Federal Tax Exemption (501 (c) 3); would provide a conduit for funds to BCOA health & welfare. *Consensus:* While it is good to pursue a means of making tax-deductible contributions to borzoi, the existing proposal seems unduly complicated. Board requested that Prudence present a simpler version at the January meeting.

**\*Dual Champion Sweepstakes at the 2014 National Specialty (Barbara O'Neill):**

The Board suggested potential judges and voted by secret ballot. Barbara will count the votes and contact the winner. The Judge will be revealed at the event Thursday, 10 April after Winners Dog. Entry: \$15.

Reminder: The Standing Rules for Puppy & Veteran Sweepstakes do not apply to this Special Attraction at our 110<sup>th</sup> Anniversary Show.

**\*Meet the Breeds (Ron Williams)**

The BCOA booth at the Javits Center (28 & 29 September) was awarded a Hound Group 4, based on a vote by the public. The banners used in the booth have been shipped to and received by Jane Schreiber. Karen Mays will send a note of thanks to Linda Deutsch who designed and created the booth.

KC Artley moved, seconded by Barbara O'Neill to make MTB a standing committee with co-chairs the chairs for Eukanuba & Javits. The motion carried. Currently, they are Chris Neale & Ron Williams respectively.

Note: Eukanuba Groups & BiS will not be televised in 2013 but will be streamed live on the internet.

**\*Format for Regional Governors' Reports (Joy Windle)** It was pointed out that the Board and for members within a region do not need the same report. The Board only needs to know of the events and issues concerning BCOA. Regional Governors are reminded to send news to the *Aristocrat*.

The current application will be modified to include instructions to send a copy to the Regional Governor.

**\*Code of Ethics** A committee to revise the current Code of Ethics (Joyce Katona, Lorrie Scott, & Joy Windle) will report in January. In the meantime, the website will be updated to reflect the version on member application.

**\*Member education guidelines:** Inform Board of plans two years before national specialty. Photographs of dogs will be used in any Member education program with owners' permission. Prudence distributed thumbdrives containing the archive of Borzoi of the past, including national specialty winners.

**\*2015 Year Book (Barbara O'Neill):** Committee will be appointed in 2014, with forms available at the Annual Meeting. Deadline for submission, November 2014. Joy Windle will proofread.

**\*AKC Studbook:** KC Artley moved, seconded by Roy Silguero to Publish names of dogs from AKC Stud Book in the *Aristocrat*. The motion carried.

**\*BTRC:** KC Artley has resigned as a Board Member on BTRC. The selection of a new member will be finalized via email.

**\*2013 AKC Presidents' Challenge:** KC Artley moved, seconded by Barbara O'Neill, that BCOA not participate this year by donating funds to this AKC fund. The motion carried.

**\*E-balloting:** Before BCOA can use eBalloting, it is necessary to 1) ascertain whether PA (state in which BCOA is incorporated) law permits eBallot, and 2) revise Constitution & By-Laws to allow eBalloting for election of officers and governors, standard changes, and constitutional amendment.

**\*BCOA Incident Report (Barbara O'Neill):** KC Artley moved, seconded by Karen Mays, to approve the report. The motion carried. Copies should be available at all BCOA events.

**\*AKC Pet Disaster Relief Trailers:** Barbara O'Neill moved, seconded by KC Artley, to contribute \$1200

to the Fund, to be divided between our six regions. The motion carried. Opposed: Lorrie Scott, Prudence Hlatky, & Carol Enz. AKC Reunite is raising funds to help supply stocked mobile trailers that deliver essential necessities for sheltering pets when and where needed to local emergency management. \*Annual Awards: Barbara O'Neill moved, seconded by Lorrie Scott, that Top Breeder Owner Handler be awarded at the annual awards banquet, using the BCOA Breed Point System, effective 1/1/14. The motion carried.

To clarify the current standing rules, KC Artley moved, seconded by Prudence Hlatky, that only BCOA members names will be engraved on the annual awards plaques, and that the only titles that will be engraved are AKC, ASFA, LGRA, NOTRA, TCC, NACA & NOFCA titles." Motion passed.

\*BCOA Facebook: Any of the page Administrators may reply to questions sent in private messages. The page is 'read only' for all but administrators.

\*AKC Owner-Handler Series: Prudence Hlatky moved, seconded by Joy Windle, that BCOA participate in AKC Owner-Handler Series at our National Specialty Show. The motion carried.

\*Selection of judges :

Barbara O'Neill moved, seconded by Roy Silguero, Judges will be selected annually. The motion carried.

Barbara O'Neill moved, seconded by Ron Williams, the breed judge not judge any borzoi specialty in the USA in the year prior the national specialty where he or she will judge. The motion carried.

Barbara O'Neill moved, seconded by Ron Williams, Breed judge not judge Borzoi at an all-breed show in the region in where that judge will be judging the national specialty for 6 months prior to the show.

Opposed: Karen Mays. The motion carried.

\*National Animal Interest Alliance book: The Board discussed the feasibility of donating copies of If I Ran the Dog Show by the Dr. Seuss Foundation to local libraries and schools. While it is a great idea, which we applaud, the mechanics of making such a donation on a national scale is daunting. At this time, BCOA will not participate. However, we urge members to do so in their communities.

There being no further business, the meeting was adjourned at 5:30 pm.

**AKC Delegate (Barbara O'Neill)**

Barbara attended the Delegate By-Laws Committee meeting, Karen Mays attended the Delegate Parent Club Committee:

**Parent Club Delegate List and Parent Club Conference List:** Pat Laurans encouraged everyone who has not already done so to sign up for this list since there will be important issues coming up and projects that will be monitored and placed on the lists.

**Dock and Crop, Peter Piusz:** Peter discussed the use of breed standards at the Eukanuba World Event and KC's promotion of Crufts in regards to the dock and crop breeds allowing AKC to use the FCI Standards at this event. He wondered if the Board approves this every year. At our last meeting we had asked Bill Feeney to follow up on this. The same rules should apply to AKC events as apply to the parent clubs.

**Breeder of Merit Program and Parent Club of Excellence Project, Larry Sorenson:** Larry indicated his committee has made some changes to the proposal and the Parent Club Committee will meet following this meeting to discuss the future of the project.

**Update Complete Dog Book Project, Daryl Hendricks:** Daryl stated everything is squared away for the New Complete Dog Book. The vast majority of the photos are at the publishers. Staff has been speaking to clubs that have not submitted photos. Clubs are able to review and give their final approval for the text.

**Update on the CGC Title, Tom Powers:** AKC is currently up to 11,500 titles. There has been an "advance" to the CGC title but no certificate for this "CGCA" level.

**Update on eBalloting/Online Elections, Bill Feeney:** Bill read an announcement that, effective September 1, 2013, AKC will permit electronic balloting in general or for specific purposes if the state law

governing your club permits this. The announcement states that “Parent clubs may conduct elections, votes of breed standard revisions, bylaw amendments and any other specific questions a club’s board of directors shall determine, via electronic balloting. Such balloting must be conducted by an independent organization which specializes in electronic balloting. A member must sign a written authorization agreeing to this method of balloting, which is revocable, which agrees to release the club from any liability should the ballot be received late or not received by the member, due to circumstances beyond the club’s control. Members not providing written authorization will continue to receive all materials via USPS. Clubs wishing to adopt this method of balloting must add the appropriate language to the applicable sections of their bylaws the next time other bylaw work is considered.” This information is on the AKC web site. Frank Holloway, Chow Chow Club, suggested compiling a list of states that currently approve eBalloting so that each club would not need to perform duplicate research to see if it is allowed in their state. Don James, Leonberger Club of America, agreed to work on this.

There are some frequently asked questions that have been published as well. Bill Feeney will see that the information from Mike Liosis is posted on the AKC Delegate and Parent Club Conference lists. Don James wrote an article for “Perspectives” that stressed that clubs utilizing eballoting must be not-for-profit clubs. Pat Laurans indicated that, at this time, eballoting only relates to parent clubs and does not cover all-breed clubs and local clubs. Pat Reynolds, Yorkshire Terrier Club of America, stated that she practices law in the state of Missouri and there is a specific law that states eballoting must be authorized in your bylaws in advance. You can’t change your bylaws at a later date. Giving blanket advice that clubs can do this and then change their bylaws could be a violation. You must check your state’s statutes. Bill Feeney indicated he would be cautious and recommended clubs do their bylaws revisions first. John Nielsen asked if AKC would provide a list of qualified companies. Bill will check on this. Katie Campbell, Basenji Club of America, advised that clubs shop around. There is economy in numbers. The more members your club has the cheaper it becomes per voting entity. Don James cautioned against hiring a firm that doesn’t do paper ballots since you need a firm that does both. Clubs can choose to opt in if they wish to utilize eballoting. Pat Laurans wondered if we would like to ask Mike Liosis to extend this option to local breed clubs. John Nielsen moved we wait a year to see how this works out before taking this step. Motion passed. Pat extended her appreciation to Katie Campbell for bringing this issue to our committee.

**Amended Minutes:** Peter Piusz noted that, prior to the meeting, it was pointed out that the minutes omitted Doug Lundgren’s comments about carting that indicated **mixed** breeds as well as all breeds would be allowed in parent club carting events, which is what the Board of Directors wants. John Nielsen moved the minutes be approved as amended. Motion passed.

**Update on the Club Outreach Program, Daryl Hendricks:** Two things came out at the last meeting regarding the Club Outreach Program. First is a clarification on who is eligible to participate. The language has been changed and an email that will go out on October 1<sup>st</sup> clarifies this. The second was a request to change the language in the email itself regarding the good things we do from an AKC perspective and this has been added to the mailing. Pat Laurans asked about the feasibility of expanding the program to include local specialty clubs and this will be looked into.

**Update on Catalogs at National Specialties, Tom Powers:** Tom announced that the Board has approved the use of a combined catalog even with different show secretaries for different events.

**Update on Fees for Juniors – Registration/Transfers, Daryl Hendricks:** Daryl stated that this proposal is still being reviewed for presentation to the Board. Pat Laurans stressed that as a committee we do not want to keep Juniors from participating and that anything we can do would be a positive move. At the last meeting Karen Spey requested the transfer fees be reduced to \$10.00 per transfer for Juniors and feels that Juniors can be identified by their Junior Number. Tom Powers asked if the committee would have a problem if there was a limit to the number of times a Junior could avail themselves of that reduced rate. This should be acceptable.

**Update on the Trailer Task Force Project, Pat Laurans:** Ninety-two days ago a group of committed individuals came together to discuss the concept of the Trailer Project. Fortunately, there was a trailer on site and everyone had the opportunity to look at it and to realize that AKC could be a part of this project. We could make a difference. Pat announced that there would be a power point presentation during tomorrow’s Delegate Meeting. At the end of the meeting delegates will be given a packet that contains

information and ways their clubs can donate and participate. Pat was also happy to say that the Pembroke Welsh Corgi Club has already stepped up to the plate and has committed to raise \$5,000.00. Two individual checks from Corgi people were attached to the pledge. Each and every club we represent is going to be able to help and to be part of something great. Pat thanked everyone for what they have done and what they and their clubs will do because this will be a significant event for AKC and AKC clubs. The committee has done a wonderful job and Staff was amazing. Pat explained there is a way for individuals to write a check and indicate this donation is being given through their club. It is tax-deductible going through CAR as a 501c-3. When delegates pick up their packet after the meeting there will be a sign-up sheet included. Those who want to put a check or credit card with it and personally start the fund for their clubs are urged to do so.

**Update on Meet the Breeds, Pat Laurans:** Pat stated she had spoken with Gina DiNardo who feels they are in pretty good shape for Javits participation-wise. She has contacted clubs that have not signed-up. Pat urged delegates to contact their clubs to make sure they are represented in Orlando.

#### NEW BUSINESS

**Introduction of Those Running for the Parent Club Committee, Pat Laurans:** Pat introduced the candidates who spoke briefly on their qualifications and reasons why they are interested in serving on this committee: Ann Bowes, Pembroke Welsh Corgi Club of America; Connie Butherus, Aftan Hound Club of America; Mary Ellen Fishler, Poodle Club of America; Ruth Ann Naun, Border Terrier Club of America; John Nielsen, English Setter Association of America; Helen Prince, Scottish Terrier Club of America; and Larry Sorenson, Dachshund Club of America.

**Breed Pictures, Pat Laurans:** Pat assumed that most of the delegates had received the same request she had from a Kitt Chambers who stated they were creating a dog and cat resource for potential pet owners looking to bring a new pet into their home. After receiving this, she contacted Lisa Peterson asking if she felt this was a good idea. Lisa responded, "I have not heard of them personally, but I would not send them any photos. They are asking you for photos for free without any explanation of usage rights, copyrite, photographer attribution or asking that you sign any photo-releases. We've had requests like this in the past. The content they are seeking will be in competition with the AKC.org breed page." So, the recommendation to you is – don't do it. If you get any other requests like this, don't do it. Sherry Wallis, Akita Club of America, feels we need to respond in some way and should indicate our breed is already represented by AKC.org. We have all the legal requirements taken care of in terms of positions with them, they are the best site to go to, and therefore we decline. Marilyn Currey, American Chinese Crested Club, expressed concern about how our breeds would be portrayed on this site. Connie Butherus is not only concerned with the narrative but the image that may be portrayed, such as a parti-colored poodle. Se feels they are going to find pictures and they are going to write something. It's going to happen whether we participate or not. Helen Prince, Scottish Terrier Club of America, questioned how they obtained the names and email addresses of the people who were contacted.

**Humane Fund, Pat Laurans:** Pat spoke with Dennis Sprung on Friday who indicated the Humane Fund still has grant money to give out and they really want to help the parent clubs. Pat read what was sent to her from Daphna Straus. "Many of you know about the AKC Humane Fund as your clubs have generously contributed towards their good works. What you may not be aware of is the fact that parent clubs can, in turn, apply for funding from the Humane Fund. Most parent clubs are involved with rescue, either directly or through a separately designated rescue arm. No matter how your club does rescue work it should apply for a grant from the Humane Fund. If your club has spent money to rescue dogs; for medical, rehab or other typical expenses, a grant from the AKC Humane Fund may be possible. Your club can apply for a grant of \$1,000.00 a year for three years for a total of \$3,000.00. If your club does not perform direct rescue activities but refers to a separate non-profit rescue organization, that organization may apply for funding, with a brief letter of reference from your parent club on club letterhead. Applications can be found on the following web site: [www.akchumanefund.org](http://www.akchumanefund.org) and are accepted on a rolling basis at any time throughout the year." The Humane Fund exists to help clubs do more for our dogs so please take a look at this opportunity when you can. Every delegate of a parent club needs to send this information to their club.



Connie Butherus recently picked up a copy of *Time Magazine*. At the end was a six page advertisement that emphasized, "Before buying a pet think of adoption first for a lasting relationship." None of us are against shelter dogs or rescuing dogs, but there was no mention of contacting the AKC or the parent clubs. At the end of the article was a list of sponsors including Pet Smart, Purina, Bayer, and the animal division of Pfizer Drug Company. This is what we are up against in terms of our mission which is the promotion of purpose-bred healthy dogs. Ann Mariah Cook, Siberian Husky Club of America, noted that when the president obtained a purebred dog there were all kinds of negative comments about why he didn't get a rescue dog. We did nothing to counter these statements. She added that she is from the state of New Hampshire and they actually do not have enough dogs in their shelters and are receiving shipments by "do-gooders" across the country sending up dogs to the shelters that are actually making a profit on placing these dogs. Why aren't we getting on top of this? Cathleen Rubens, Fayetteville Kennel Club, stated there have been some articles written on this subject in her area. Dogs are being bought or stolen and transferred to other areas in the northeast. This is becoming a profitable business and now we are in competition with them as well. Connie Butherus added that this rescue scam should be exposed. Katie Campbell, Basenji Club of America, suggested that it would be helpful for Daryl Hendricks to put together some sort of "statement page" that will help people respond when they are confronted with comments regarding obtaining a dog from a shelter. Assistance with verbiage would help us get our message out.

As there was no further business, on a motion by Connie Butherus the meeting was adjourned at 10:55 A.M.

## **Regional Governors Reports**

### **HEALTH COMMITTEE (Ginger Jones)**

#### CANINE HEALTH FOUNDATION GRANT RESEARCH:

\*I received the status report of the two heart research projects that we supported this year, Grant #1753 Identification of Genetic Factors that Alter the Severity of Cardiomyopathy and Grant #1760 Use of Gene

Therapy to treat Dilated Cardiomyopathy and also the update on Grant #1151 Molecular Basis of Tricuspid Valve Dysplasia. See attachments providing the complete updates on all three.

\*I received some of the CHF Oak research grants for 2014 grants year cycle. Of the 19 grants I received and reviewed, there are two that are of particular interest to the borzoi breed and I would strongly recommend that we support both. At the February board meeting the board approved \$3000 expenditure from the Health Fund for Bloat research. I would recommend we put the money towards this particular study as it shows more promise and has multiple investigators with great depth of knowledge. If our health fund can sustain it, I would request we support for \$2500 the additional study on Osteochondrosis as this is a disease that affects many borzoi and the outcome of this research could be dramatic for the breed. Here are the abstracts for each:

**\*2078: Development of a Regenerative Medicine Technique to Treat Cartilage Disorders in Dogs**

*Principal Investigator: Dr. William Brian Saunders, DVM, PhD; Texas AgriLife Research*

*Total Grant Amount: \$120,872; Grant Period: 1/1/2014 - 12/31/2015*

*Project Abstract:*

*Osteochondrosis is a common and debilitating disease affecting large, athletic dogs.*

*Osteochondrosis is caused by abnormal endochondral ossification, the process by which growth plate cartilage adjacent to joint surfaces transitions from cartilage to bone. The result is excessively thickened cartilage that partially or completely separates from surrounding bone. Cartilage separation exposes the joint to underlying bone and creates a large loose body, termed a joint mouse, within the joint.*

*Surgical or medical treatment results vary widely based on the affected joint, size of the osteochondrosis defect, and intended purpose for each dog.*

*Treatment options for osteochondrosis have remained essentially unchanged for decades. Tissue engineering represents a promising treatment alternative for dogs suffering from OC. Dr. Saunders believes the key to successful tissue engineering involves generation of regenerative osteochondral plugs, or ROPs. ROPs are tri-layered cylindrical plugs composed of hydrogels seeded with adult mesenchymal stem cells*

*(MSCs). Each ROP layer is composed of materials that closely mimic specific zones of the joint and adjacent bone. ROP layers are bioactive, directing encapsulated MSCs to differentiate into specific tissues to more efficiently restore normal joint anatomy. Dr. Saunders will optimize the materials used to generate ROP layers and will determine if MSCs from tissue lining the joint (synovium) or inner cavity of bones (bone marrow) more effectively reconstruct native cartilage, transitional tissue, or bone. This work represents an important advance in canine regenerative medicine and is highly applicable to dogs with osteochondrosis or other common joint ailments such as osteoarthritis.*

**\*1935: Abnormalities in the Stomach's Ability to Contract Predisposes Large-Breed Dogs to Bloat**

*PI: Laura L. Nelson, DVM; Michigan State University*

*Grant Amount: \$233,774.00*

***Dr. Nelson's grant was responsive to our RFP 'special topic of interest' request: Characterization of pathways mediating gastrointestinal motility changes associated with GDV, including utilization of intraluminal sensors and non-invasive sensing technologies to monitor/measure motility in vivo.***

***Abstract: Gastric dilatation-volvulus (GDV or "bloat") is a devastating disease common in large and giant-breed dogs. Occurring most frequently in older dogs with a close relative who has also suffered the condition, the stomach becomes both displaced and distended with air. Without emergency medical stabilization and surgical intervention, affected dogs quickly experience shock, damage to the stomach***

wall, and death. Most of the research relating to GDV has described risk factors for the disease, determinants of outcome with treatment, and the effectiveness of preventive surgery (gastropexy). However, the underlying cause of GDV remains unknown. Abnormalities in the ability of the stomach to contract have been documented in dogs after naturally-occurring GDV. An analogous stomach condition in cattle, left-sided displacement of the abomasum (LDA) has been shown to, in some instances, be associated with abnormalities in the motilin gene. Motilin is an important driver of stomach contraction. This suggests that LDA and potentially GDV may be primarily caused by a stomach that does not properly contract, and that this condition may be inherited. The goals of Dr. Nelson's study are to determine the relationship of abnormal stomach contraction with GDV and to define the biochemical and genetic alterations that may be associated with these stomach abnormalities.

In the long term, they hope to develop a test to identify dogs at high risk for GDV that would allow selective breeding to eliminate the condition and to determine which dogs will benefit most from prophylactic gastropexy or other preventive therapies.

The Purina Parent Club Conference was held August 9–11 in St. Louis. As always, the conference was outstanding and many topics were covered. Topics covered the following: Canine Epilepsy by Dr Willaim Thomas, Inherited Cardiomyopathies by Dr Kathryn Meurs, New strategies to prevent Canine Posterior Capsul Opacification by Dr Heather Chandler, Use of Biomechanics to investigate and treat cranial cruciate ligament ruptures by Dr Gina Bertocci, Bloat and Multiple Organ Failure by Dr Elizabeth Rozanski, The Genius of Dogs/Dognition by Dr Brian Hare, Canine Hemangiosarcoma by Dr Jaime Modiano, The Cytogenomic Landscape of Canine Cancer by Dr Matthew Breen, Infection and Immunity by Dr Adam Birkenheuer, Regenerative Medicine for Soft Tissue Injuries by Dr Sherman Canapp, Cytokines and Canine Nutrition Dr Deborah Greco, High Risk/High Reward Gastroenterology by Dr. Jody Gookin, Canine rehabilitation through Physical Therapy by Dr Janet Van Dyke and last but not least, Genetics 101 for Dog Breeders by Dr Danika Bannasch. The seminars were followed by a half day participation in rotating group discussions with the speakers. Also included in these panel discussions were Dr. Anita Oberbauer, Dr Jerold Bell, Eddie Dzuik, and Dr Urs Giger. The Canine Health Foundation will be releasing each of the seminars in regular podcast that are just starting this fall. I will be sure to post this info to the BCOA news list with my personal input of the seminars content. They will be absolutely fascinating!

**BCOA Legislative Liaison (Rita Rice)**

\*First, I would like to apologize – I didn't look at the minutes until I was preparing this report, and missed the request to write a letter in support of VA's Mobile Vet Bill. I'll check to see if this is still actionable, and have those letters written by October 22 (and will forward to Joy). I promise to be more attentive in the future!

\*In addition to my membership with BCOA, I am also a member of SDCA. The SDCA President is interested in the work I'm doing for BCOA, and has asked if I'd be willing to provide SDCA with the same updates. Please let me know if the BCOA Board has any objection to this.

\*Most of the State Legislatures are in adjournment, so I have no updates on State legislation.

USDA/APHIS UPDATES AWA GUIDELINES

There has been a lot of activity in the past few weeks, due to USDA/APHIS issuing updated guidelines for the Animal Welfare Act.

The new guidelines impact:

Breeders who own more than four breedable bitches; and

Sell borzoi as companion animals; and

Sell through Internet transactions where the dog is shipped to the buyer sight unseen.

Breeders who own more than four breedable bitches may use one of several loopholes:

They may sell all companion puppies in face-to-face transactions, where the buyer has the opportunity to view the puppy prior to purchase

The buyer may visit the puppy prior to shipment at a later date

They may choose to only sell to other breeding homes (show homes)

OR, they may choose to apply for a USDA license and undergo inspection.

Clarification is still being sought regarding details of the new ruling. I attended the conference call between USDA/APHIS and the AKC on September 19, and have already issued a brief report summarizing the results.

I emailed the USDA on September 25 requesting clarification regarding breeders with more than four breedable females who assist in NBRF or BRNC rescue; due to the government shutdown, I haven't yet heard back (though I did receive an email acknowledging receipt and promising an individual response).

CANADA UPDATES REGULATIONS REGARDING IMPORTING DOGS

The [Canadian Food Inspection Agency \(CFIA\)](#), which oversees animal imports into Canada, has clarified its regulations regarding the importation of "commercial" dogs, which includes dogs for shows and exhibitions as well as breeding dogs.

**\*FOR DOGS UNDER EIGHT MONTHS OF AGE ENTERING CANADA FROM THE UNITED STATES**

Dog owners and exhibitors with dogs under eight months of age are now required to present proof of their entry in a dog show, trial, or other competitive event when crossing the American-Canadian border.

This is in addition to the already-existing requirements of:

- A rabies certification (does not apply to animals three months old or younger)
- a veterinary certificate of health whether or not they are accompanied by their owner
- a microchip

Individuals without proof of entry in a show, trial, or other event are instead required to contact the CFIA [Animal Health Area Office](#) for the province they intend to enter at least 30 days before the dog is imported to apply for the permit and allow sufficient time for processing prior to entry into Canada.

**\*FOR DOGS OVER EIGHT MONTHS OF AGE ENTERING CANADA FROM THE UNITED STATES**

**Dog** owners and exhibitors with dogs over eight months of age are required to present a valid rabies vaccination certificate issued by a licensed veterinarian. (Dogs imported for research purposes must meet more stringent requirements.)

Individuals interested in taking dogs into Canada for show, trial, or other event purposes are encouraged to refer to the CFIA's Automated Import Reference System (AIRS)

at <http://inspection.gc.ca/animals/terrestrial-animals/imports/airs/eng/1300127512994/1326599273148>.

The system provides detailed requirements personalized for each user.

Houston, TX may require ALL breeders who live within the city to be licensed. On October 15, the administration of BARC, the City of Houston's Animal Shelter and Adoption Facility, held a stakeholders meeting on its recommended revisions to Chapter 6 of Houston's Code of Ordinances concerning animal-related regulations. Under BARC's current draft, all dog breeders in Houston will be required to be licensed as "commercial breeders." This is of great concern to AKC. PENNSYLVANIA SB1126 MOVES DOG LAW TO HEALTH DEPARTMENT

Introduced October 10, 2013 by Senators Dinniman, Alloway, Erickson, Vogel and Greenleaf, SB1126 amends the Dog Law by moving responsibility from the Department of Agriculture to the Department of Health. The Department of Health would carry out all the administrative and oversight tasks currently required by the Dog Law, including the regulation of dog kennels; the collection of complaints and tips alleging violations of the Dog Law; the seizure of dogs from illegal, unlicensed kennels; and the collection of dog-license, kennel and out-of-state-dealers fees. Senators Dinniman (D, Chester) and Alloway (R, Franklin) state with Dog Law enforcement in the Department of Agriculture, dogs are treated as any other agricultural product and moving them under the responsibility of the Department of Health correctly changes the focus to health, welfare and safety. Senators Dinniman and Alloway plan to unveil a package of bills October 22 with a public dog rally at the Capitol.

**Meet the Breeds 2013 NYC (Ron Williams)**

The 2013 AKC Meet the Breeds (Cats & Dogs) event at New York's Jacob Javits Center took place September 28 & 29. This year's team consisted of Linda Deutsch, Lorene Connolly, Joy Windle and Eddy; along with Shea and Melody. The event planners were estimating around 20,000 visitors each day. I'm not sure if they met the number or not. However, it felt like they did. The doors opened at 10 and the first wave of visitors made their presence known.
