The Board instructed Barbara to vote for Dr. Charles Garvin, Dalmatian Club of America; Ronald Menaker, Rockford-Freeport Illinois Kennel Club; and James Dok, Gig Harbor Kennel Club for three AKC Board seats.

Beverly Taylor Rescue Committee (Shen Smith)

The board members reviewed the report from this committee, and the financial reports from the two rescue organizations. Lorrie Scott moved, seconded by Joyce Katona that \$6000 be given to Borzoi Rescue Northern California, and \$12,000 to the National Borzoi Rescue Foundation. The motion carried.

Club Inventory (Barbara O'Neill)

Futurity Event (Joyce Katona) Because the artist's estimated shipping costs were far less than those actually incurred, Joyce Katona moved, seconded by Prudence Hlatky to pay artist the actual shipping costs. The motion carried.

Unfinished Business

Governors are reminded to continue to remind members to use the *Aristocrat* to advertise accomplishments. The incomes from these ads fund BCOA activities.

Borzoi Health and Welfare Foundation The Borzoi Health and Welfare BHWF formation committee consisting of Rita Link, Dee Jones and Prudence Hlatky met during the AKC / Eukanuba show and reviewed the concerns of the BCOA Board of Directors. At this time the BHWF committee has elected to proceed with its original plans and to file for incorporation and nonprofit status.

The BCOA has changed the name of BCOA Borzoi Rescue to Borzoi Rescue & Welfare and asked that BHWF funnel monies to this committee. For BHWF to maintain a tax exempt status it has to be funding Borzoi health and welfare events within the BHWF's charter. The foundation cannot be just a cash resource.

As BHWF wishes to have a close relationship with the BCOA it will hold three board seats available for BCOA appointees. Currently Rita Link is acting chair elect, Dee Jones acting secretary and Prudence Hlatky board of directors.

Code of Ethics (and Guidelines for Breeders): Revision has begun. Joy will make the first draft available to the Board for suggestions.

2015 Yearbook: It was agreed that we need a hard copy; an on-line version is not adequate. The deadline for ads will be in the fall of 2014, for delivery at the 2015 National in Ohio.

New Business

Standing Committee Chairs for 2014 (Rebecca Peters-Campbell) Several replacement chairs were suggested; the list will be published when those positions are filled. Joy Windle moved, seconded by Ron Williams to approve the new list. The motion carried.

Borzoi Referral Program for BCOA Members: Barbara O'Neill proposed a committee to research possibility of adopting BR-NC Breeder Referral Program with Dee Jones as Chair. Lorrie Scott will serve on the committee. Seconded by Joyce Katona, the motion carried.

BCOA member-breeders' link to BCOA webpage: Discussed setting up a Member/Breeder page on website. The consensus was that we should move forward on that, with further action pending development of the revised Code of Ethics & Guidelines for Breeders.

Pet oxygen masks: Barbara O'Neill moved, seconded by Prudence Hlatky, that we donate up to four (4) pet Oxygen Mask kits (\$300) to the local fire company at each year's national specialty, beginning with the Albuquerque Fire Department at the 2014 National Specialty, funded by BCOA Welfare & Rescue Committee. The motion carried.

Challenge trophies: Because of the expense of shipping the perpetual & challenge trophies from national to national, Barbara O'Neill moved, seconded by Lorrie Scott, that we observe a moratorium on any new challenge trophies. The motion carried with Prudence Hlatky & Robin Casey opposed. Over \$4000 in 2013 was spent shipping these heavy, breakable trophies.

- * Exhibitors participated more than ever, bringing 25,323 new entries through October for a projected total of about 3.2 million this year - the largest number in the history of the AKC.

A short introduction-I have been active in the Borzoi breed for the last 20+ years and a BCOA member since 1997. First, in some local rescue while in Colorado and then into lure coursing and conformation events. To this date I have owned/co-owned multiple specialty winners and a few best in field dogs. I have bred three litters and participated in many others. My highest honor was in owning the 2004 Centennial BCOA BOB winner. I have also held offices in the PVBC regional club-to include president, recording secretary positions and served on the board of governors for PVBC. I am currently co-chair for the BCOA "Ready Borzoi" disaster planning committee. I am also currently an AKC licensed judge. I'm honored to have been chosen to represent the Region 5 membership.

While only having just taken office, I have asked the Region 5 members what they as BCOA members would like to see happen in the general membership and board. The responses were . . .

. To continue to improve communications between the BCOA board and general membership. Many members still feel they have no voice or if they "sound off", it "falls on deaf ears". This to include having the general membership make more of the decisions the club faces rather than a majority of issues being decided strictly by the board.

. Develop ideas to encourage more membership participation, through volunteer involvement with breed health, activities for companions, coursing, conformation as well as club enrichment overall.

. Encourage BCOA members to participate and recognize the importance of open field events as this venue is quickly losing younger members and is endangered.

I have very recently started a Region 5 Yahoo group and strongly urge all Region 5 members to join. As some may know there is also a BCOA members only list. I STRONGLY encourage all members to use this group as well. Even if it is just to say I agree or offer suggestions and concerns. We can't try to fix things if members don't speak out! It is my hope that these groups will open more lines of communications for all of us and enable myself and the board to quickly address any problems or concerns, as well the ability to offer suggestions and share ideas! I will also be sending those members that do not have computers, a periodic "update" mailing of all topics, news, etc. we will be discussing.

Region 6 (Joyce Katona)

There were two Specialties in my region on November 16. I attended the Borzoi Club of Greater Omaha Specialty and held a regional meeting following the judging.

The meeting was well attended and I updated those present on what was currently happening with the APHIS ruling and the wolf hunting issue and the Board's position on both. We also discussed the upcoming National in NM and I answered questions. I encouraged regional members to volunteer to help with the 2015 National. Members expressed appreciation for the updates I send and thanked me for making the effort to attend their show.

Due to the concern of holding two Specialties on the same day in the one region, I asked BCGO if they were happy with the entries for the Specialty and they said they were and that this year's entry was larger than last.
