**AKC DELEGATE (Barbara O'Neill)**

The AKC Delegate meeting was held Friday, December 11, 2015.

Candidates for the Board of Directors were introduced and spoke on their goals for the AKC.

1. The election will be at the March 8 meeting. There are three vacancies and the candidates are:

Gretchen Bernardi, Mississippi Valley Kennel Club

Linda Ayers Turner Knorr, Greenville Kennel Club

Thomas Powers, Kennel Club of Beverly Hills

2. The Delegate Body approved the use of electronic documents (premium list, judging program, and catalog) for clubs. Exhibitors still have the option to request printed documents if they wish.

3. The amendment to eliminate term limits for Board members was not approved.

4. The amendment to recognize multiple levels of Grand Championship titles was approved.

5. An amendment would permit Delegate judges to charge a fee of up to \$150. It is not clear to me if that is per day or per assignment. We will be asked to vote on it at the March 2016 meeting.

6. The next Delegate Meeting will be held Tuesday, March 8, 2016, Newark, New Jersey. An agenda has not been determined.
