On a negative note, we were severely penalized by the hotel for overestimating the number of hotel rooms that would be used. Initially, the penalty was \$22,250 but was reduced to \$12,250 out of the kindness of their hearts. Apparently, although we had an average entry at the specialty, an unusual number of people chose not to stay at the host hotel. The penalty negated all the profits, plus some, after all the hard work.

The question may soon come as to whether or not to continue to offer a first-class facility for holding the National Specialty for these Aristocrats of dogs. In all my years in the BCOA I always thought and worked toward making the National a memorable yearly event, an event to showcase these beautiful creatures in a setting worthy of their heritage. As much as I hate to admit, I may have been wrong. Maybe our members think of it as "just another dog show." Maybe our members and exhibitors would like to have it return to the days when we had only outdoor judging at a park and only a host hotel for a banquet and auction. No Futurity, no Opening Reception, no shuttle service to the hotel or park, no bathing and grooming room, no food or water on the grounds...you get the point.

I think it is vital for the start of the millennium to choose a direction we want to see the BCOA National go in. We definitely cannot take another financial hit like we did in Denver or we will not have a choice in the matter. It will be Motel 6 and the park down the road.

NACA BORZOI SPRING CUP, APRIL 17, 1999

Borzoi Hunt 4/17/99

The spring Borzoi hunt is ready to run. This morning the weather is cooperating with sun and moderate temperatures. Karen Ackerman asks me, "Where we should take 21 Borzoi?" On a gut feel-

ing I mention an area south of town and not too far out. There have been no hunts there that anyone can remember. Well it's "hero" or

"zero" for me as

we head out.

The area is west of the road and a moderate incline for half a mile or so to a vast open flat plain. The sage is knee high and sparse enough for the Borzoi

to have running room. The sage gives way to barren ground at the break and out on the flats. The judging can be done from a position at the rim and parallel to the hunt

movement.

grade toward the top. Within minutes the first jack breaks cover and heads up hill. The dogs pursue at a distance that never diminishes. Ruslan leads and only once does Pete takes the lead while Indy negotiates some brush. The dogs go out of sight with Ruslan still in the

lead. Ruslan advances.

Now with everyone wide awake and ready for some action the gallery moves out. The next jack jumps from under Falco, Nugget and Mazurka's feet and runs hard.

The tally-ho is sounded and the dogs leap to the task. The hare is closed on quickly and takes to ground in a convenient hole.

With the first three dogs on line, Ruslan, Pete and Indy, the gallery* moves up the



Falco led the sprint and advances.

With the third course of Bobbi, Velika and Kara in slips and the gallery moving slowly through the sage, a jack leaves cover and runs north along a small ditch. Kara makes a good run up* and the jack wrenches* left. Velika, close at hand, takes the jack and turns* him back downhill. The jack under pressure wrenches back left. At this point Velika is spent and slows as Kara tail chases* a ways. Velika and Kara advance.

Working our way across the face of the landscape we move north. After some time a large strong whitetail leaps from a depression, Sonja, Latoka, and Pushkin are off. Pushkin runs-up the jack with incredible speed. As he comes along side

he reaches down and the hare

turns. With great admiration I watch Pushkin maintain his lead and position and turn the jack hard three times. Sonja has been hedging for Pushkin and holds the jack between them. Pushkin reaches down once again to grab the jack and the hare makes his footing count and accelerates to the open ground and earns his freedom. A superb run and Pushkin advances. He owes Sonja a big "thank you" for the hedging work.

We hunt on and get near a gas pump station and the ground breaks into gullies and drainage ditches. A jack breaks and heads up hill and Lena follows him out with Lady and Kochka close behind. Lena pushes and the jack zigzags through the brush and across a ditch. Lady takes the lead as if a light goes on and the closeness of live game is realized. Lady pushes on and makes a run at the hare forcing two quick wrenches. At this point the hare turns back down hill toward the pump station. The hare and hounds have covered three or four hundred yards by now. Kochka has run out and Lena is slowing. Lady with renewed

interest pushes on and stays within yards of the jack. The run ended abruptly after a half mile when the jack runs in a culvert pipe and safety. Lady advances, a borzoi with some staying power.

Along the road we find our sixth jack ready to run. He leaps to the task and the hounds are put on his trail. Anna

and Terry run neck and neck with Chaco in close. Anna moves up on the jack and turns him right and then wrenches left.

Terry keeps the jack honest and Anna catches up for some more work. Anna pushes and the hare wrenches first right then left and holes up in another drainage pipe. Anna advances.

Our last prelim is on line and we are moving south along the east side of the road. It has been some hours since we have pushed out a jack. Nerves are a little eased and the hunt is relaxed. (That means everyone is talking and not paying attention to the hunt.) A strong jack is up and running straight out in front of the gallery and the hounds, Maggie Mae, Vanya and Bubba, are slipped. Vanya has only one thing on his mind - that big jack!! Vanya sprints straight away forty yards and grabs the jack from behind for a UK* and advancement.

The first final is slow to start as the dogs, Vanya, Ruslan and Lady, are not well

sighted. Then as the jack turns into the open the hounds get running. Vanya leads out and never makes up ground on the hare. The tail chase is over with Vanya a slight winner.

> The second final is off and Anna runs up quickly and forces a hard turn right. Pushkin is there to press the hare as Anna recovers and regains the lead. Anna makes a grab at the

hare and turns him into Falco and Falco makes an unsuccessful grab. This jacks hide is in danger of becoming a nice warm pair of gloves. Anna pushes in for another turn left and then right. Falco again hedges the jack back to Anna for the snapping jaws to again barely miss taking the prize. Anna is now spent and Falco follows the jack over the ridge and out of sight. Anna and Falco complimented each others work and earned almost equal scores with Anna getting an extra point.

The third and last final is a brace. When this jack comes up in high gear the brace has their work cut out for them. Velika runs up and pushes the hare to wrench left, then right. Kara takes over and reaches down for a failed grab. Velika again leads and the jack drops his ears
