BCOA Health Committee Report

National Breed Health Survey

reetings! I am honored and very excited to have been appointed to chair the BCOA Health Committee. The other members of the health committee are Alice Reese, Maureen Bardwell, and Barbara Yoon. I feel fortunate to be working with such a motivated group; we will all be doing our best to address issues of general breed health, specific health concerns, and education. Alice Reese will be arranging health seminars at the National Specialty each year, and Barbara Yoon and Maureen Bardwell will be helping with fund raising.

One of the proposals we are working on is a national breed health survey. This survey would provide a snapshot of the breed health at the present time. By asking detailed questions about a wide range of health problems (such as hypothyroidism, cardiac diseases, cancer, epilepsy, bloat, autoimmune problems, infectious diseases, and many other areas), as well as feeding habits, vaccination protocols, life span, reproductive health and so on, we hope to gain statistically valid information about the incidence of a wide range of health problems (or even maybe the lack thereof!!) across the breed. Another (hopeful!) benefit would be to try to get information on diseases that have an official registry, but are voluntary - like OFA for hips, elbows, and thyroid. We will include questions about any testing done, and results, even if the results were not registered with OFA.. have hips ever been radiographed, and what was the diagnosis by the veterinarian? Thyroid panels (hopefully not just T4, but any information will be useful). Obviously having OFA certification carries more weight, since there is a panel of orthopedic experts who evaluate the hip radiographs, but all information will be useful. The survey design will allow us to have information on both "official" health clearances, as well as diagnoses of problems by local veterinarians, that may "slip through the net" by not being registered if abnormal.

Lou Avant, DVM is chairman of the BCOA Health Registry, which is a voluntary registry for breeders or owners to register either dogs that have passed various health tests (OFA, CERF, thyroid screening, cardiac screening) or a separate registry for health problems. These registries provide a huge service to the health of this breed. In time the registries will provide valuable information about specific dogs who have passed the tests, or conversely may help to provide information about specific health problems in dogs or groups of dogs.

Both the health registry and the national survey are of vital importance. The breed health survey differs from the registry in several important ways. First, one survey (between 10-15 pages long) will be completed for each dog, up to 10 dogs for each person (to avoid over representation of any group in the overall statistical results). This survey will be conducted by a person from outside the breed, who has expertise in the area of conducting health surveys for national breed clubs, and who will guarantee absolute confidentiality of the respondents. We are evaluating proposals from several individuals to find a researcher to work with us on this survey. Another key element is working to maximize returns of the surveys. Each and every person who owns a borzoi is a valuable source of information. We need your help! All of you! If we can get a return rate of over 50% we're doing

OK; let's work together to get a 60 or 70% return rate! There is no reason to avoid sending in your response; we are interested in the health (or illnesses) of your borzoi as a part of the overall population only.

What will we do with the information? First, we will report all our findings back to the fancy. There may be some surprises; diseases that we all know are "out there" turn out to be a much larger problem than we originally thought.. others may be less prevalent than we thought. (In order for ANY of this information to be accurate, we must have a large sampling of many borzoi from across the country and from all different backgrounds. We will probably have a general mailing to all club members (any Borzoi club in the US), as well as possibly putting the survey on the BCOA web site for non-members of clubs. The key is we must reach as many owners as possible, and get as many surveys back as possible). The actual incidence of a particular health problem can be used to help make decisions about what direction to take in funding research. Finally, some of the information may be helpful to research already under way or proposed.. in ways we obviously won't know until the survey is complete.

In the next few months, we will be working to put together a proposal for a national breed survey that is economically feasible, provides statistically valid results and gives us vital information about the health of our Borzoi as a breed. After that, it's up to the individual owners and breeders to make the survey a success let's all work together on this!! You can make a difference.

Voluntary Health Registry

he BCOA Voluntary Health Registry is off and running!!! THANK YOU!! To date, 18 Certificates of Good Health have been issued, eleven bronze and seven silver. Breeders and owners alike are also making use of the Health Records Registry. At this time, twenty-eight dogs have been registered documenting various events from early onset cancers to "I lived to be TWELVE."

All of this information can be accessed via our on-line website at: http://www. borzoiclubofamerica.com/healthreg/ index.htm. Hard copies are also available upon special request for those without Internet access.

There has been some confusion concerning the requirements for the various certifications so I thought would use this opportunity to clarify what is involved in these testing procedures.

Eyes:

The requirements for certification are as set forth by the Canine Eye Registration Foundation (CERF). This registry requires that a licensed member of the American College of Veterinary Ophthalmologists (ACVO) certify your dog to be free of any heritable eye disease. Your ophthalmologist should have plenty of forms but additional forms can be obtained directly from CERF at 1-765-494-8179. The exam is painless, noninvasive and requires no sedation. For a small fee, once a form has been properly filled out, CERF will register your dog in their database as being free of any heritable eye diseases at the time of the exam. This certification is good for one year; the examination must be repeated annually for your certification to remain valid. The BCOA Health Registry accepts both CERF registration numbers and properly filled out CERF forms that have not actually been registered with CERF. If not registered directly with CERF, your dog will not be included in the CERF registry but he/she will be included in the BCOA Certificates of Good Health Registry.

Hips:

Certification in this registry designates that your dog has been found to be free of radiographic evidence of Canine Hip Dysplasia. The x-rays may be taken by any veterinarian but, for recognition by the BCOA Health Registry, you must submit them to The Orthopedic Foundation For Animals, Inc. (OFA), to PennHIP, or have them read by a board certified orthopedic surgeon. Only a one-time certification is required if testing is performed after the animal is two years of age. The proper forms can be obtained from OFA at 1-442-573-0418.

The procedure is noninvasive and requires that an x-ray be taken with the dog lying on his/her back and the rear limbs extended. Sedation is not required but this can be a mildly uncomfortable procedure and some dogs DO object to the positioning; therefore, many veterinarians prefer mild sedation to increase the chances of getting a readable film.

Elbows:

Certification in this registry designates that your dog has been found to be free of radiographic evidence of any degenerative joint disease of the elbow. The x-rays may be taken by any veterinarian but for recognition by the BCOA Health Registry, you must submit them to OFA or have them read by a board certified orthopedic surgeon. Only a one-time certification is required if testing is performed after the animal is two years of age. The proper forms can be obtained from OFA at 1-442-573-0418.

The procedure is noninvasive and requires that an x-ray be taken with the joint in extreme flexion. Sedation is not required but this can be a mildly uncomfortable procedure and some dogs DO object to the positioning; therefore, many veterinarians prefer mild sedation to increase the chances of getting a readable film.

Knees:

Certification in this registration denotes that your dog has normal or non-luxating patellae (the knees cannot be popped out of joint) at the time of the exam. Certification will be granted to any dog that is normal at the age of twelve months or older. It is recommended but not required to have periodic reevaluations because joints do change as an animal matures. For the purposes of the BCOA Health Registry, only a one-time certification will be required on dogs examined at twelve months of age or

older. The Registry will accept either an OFA number or a properly filled out OFA form denoting the knees are normal. This is a very simple and nonpainful exam and can be performed by any veterinarian and should be easily performed at the time of your dogs annual physical.

Thyroid:

Certification in this registry demonstrates that your dog has been tested properly and has been shown to be free of evidence of hypothyroidism at the time of the test. It is recommended that testing be performed at ages 1,2,3,4,6, and 8 years. For BCOA Health Registry certification purposes, the test is valid for one year.

The BCOA Health Registry will accept OFA certification numbers or normal lab results from any of the following laboratories:

- 2) Diagnostic Laboratory New York State College of Veterinary Medicine Cornell University, Upper Tower Rd. Ithaca, NY 14851
- 3) Hemopet W. Jean Dodds, DVM 938 Stanford Street Santa Monica, CA 90403

Hearts:

Certification in this registry denotes that your dog is free of overt cardiac abnormalities at the time of the exam. The certification is valid for one year and the test should be repeated annually. The clinical cardiac examination is noninvasive and requires no sedation. It should be conducted in a systematic manner. The arterial and venous pulses, mucous membranes, and precordium should be evaluated. Heart rate should be obtained. The clinical examination should be performed by an individual with advanced training in cardiac diagnosis. Board certification by the American College of Veterinary Internal Medicine, Specialty of Cardiology is considered by the American Veterinary Medical Association as the benchmark of clinical proficiency for veterinarians in clinical cardiology, and examination



BCOA American Kennel Club Quarterly Report, 12/14/199

s I sit here preparing to write my December report, and sort through two days of my own personal notes, mailings from AKC, minutes from AKC, editorials from various

sources, and AKC publications, and independent publications, newsletters, etc., I find myself overwhelmed with the problem of not what to report, but what to omit! This is indeed the "Information Age," before even turning on ones computer!

I would like to mention two new AKC publications. "Courser" Nov/Dec 1999, Volume 1 Issue 1, is now available. It lists all AKC coursing events, winners, and articles of interest. Plus some great coursing photos. Subscriptions are available, \$19.93 for six bimonthly issues. Call 919-2339767.

The second one is called "Taking Command." This is "A Publication of the AKC's Canine Legislation Dept." This publication is included in our Delegates Information Packet, which is given to us at the end of each meeting. It highlights everything from breeding restrictions to cruelty, through insurance, dangerous dogs, hunting, limit laws, and other legislation, which has an impact on dog owners.

- i.. Cosponsored "Pet Night" reception for members of Congress on Capitol Hill
- i.. Attended National Conference of State Legislators (NCSL) annual meeting
- k.. Assisted with disaster relief efforts before, during and after Hurricane Floyd" Also of special note is the fact that in Oct. United Airlines canceled its scheduled embargo on carrying pets as excess baggage during the period of Dec 15th through March 15th. AKC objected to the embargo, and the fancy inundated the airlines with e-mails and letters of objection to the proposal. United we can make a difference! (No pun intended!)

The meeting on Tuesday began with usual morning forum. Delegate Ralph Del Deo gave a report on the work being done to revise the disciplinary system, and Trial Boards. This committee would like to see the process speeded up, but still conducted in a fair manner. In brief, a panel of three would hear a case and decide the penalties. Events Committee appeals would be heard by Trial Boards.

In all cases the Board of Directors will always have the final decision, and responsibility of setting the penalties of those cases which come before them.

The next speaker was Nick D'Altilio, Chief Operating Officer, who gave us an update on the reengineering process, which is not going on at the North Carolina offices. It is planned that eventually all event correspondence will be done over the Internet, which will save on filing, time involved, etc.

After the morning forum, the meeting was called to order. CEO David Merriam told us of a plan to license professional handlers. Also, AKC is trying to expand the Foundation Stock Service to include more breeds.

President Al Cheaure' took the floor and gave a talk and update on AKC's newly improved website. An amazing 4 million people viewed the website the first month. AKC is partnered with Yahoo. President Cheaure' told us that the AKC website has the capacity to handle 40 million views a day! AKC is working with two veterinary links and studying the capability of having individuals and clubs have their own web pages within AKC's site. Progeny reports were available, but have been rescinded, due to some complaints. The Board will review this. Hopefully, this invaluable information will be reinstated.

The DNA parentage verification program is having significant success. A decision has been made to have compulsory DNA testing, beginning this summer, on frequently used sires. The number of litters, which is to be a specified number, has not yet been decided upon, but "seven" was mentioned.

Later in the meeting David Merriam informed us that the Board approved a rule amendment which would permit the recording fee to be raised to not more than \$1.50 and entry. It was also interesting to learn that the Board approved the in-vitro fertilization of a bitch! This on a one-time basis, but it opens up a whole New World to us.

Bob Slay talked about the DNA parentage program, and the use of forensics to identify fraudulent handwriting signatures on registrations. Both programs have been very successful. There are 40,000 DNA samples on hand now. Starting in 2000 if problems are found with parent verifications supplied by DNA results, registrations of any litters in which mismatched DNA are found may be canceled.

Our next meeting in March will be the annual elections. At this writing there has been only one petition from the floor. I feel the slate of nominees presented to us by the nominating committee is an outstanding selection.

More BCOA members have been contacting me, mostly through e-mail with questions or concerns. I hope that you will continue.


