BCNE is planning a fun group activity to kick off their 10th-year anniversary in June. Supported entries are July 8, 2000 with Farmington Valley KC with an all-breed entry of 3,000 dogs and an allfemale panel; Sept. with Northwestern KC and Nov. with South Windsor KC. There will be things for everyone on that weekend. Also happening are the Flatirons and Evergreen shows in Longmont for conformation and obedience folks. Unfortunately, there will be no hog barbecue served there and it's two and a half hours north of Colorado Springs.

The Rocky Mountain Borzoi Club will be holding its fall independent specialty on Labor Day, September 4th, in Longmont. This will allow folks to hit the Cheyenne, Wyoming weekend (September 2 and 3) and make our specialty on Monday. The show will be held outdoors and food will be available.

BCOA Health Registry

Why should I Participate?

The Borzoi Club of America's Health Registry rewards both owners and breeders whose dogs have been certified to be free from specific heritable diseases. The Health Registry provides reliable information which can be used to decrease the risk of passing on a genetic problem to another generation. Rather than relying on 'word of mouth', the BCOA Certificates of Good Health provide documentation that an animal has passed the tests and is free from the stated disease. As the program continues to grow, many breeders are now using the Certificates of Good Health as an eligibility requirement for selecting mates. For potential buyers, the Certificates provide another layer of confidence that they are purchasing a healthy animal.

Using the On-Line Registry

Once you've decided to participate and register your dogs in the Registry, you should become familiar with the website. Searching the Internet site is quite easy. I'll use a made up scenario with one of my own dogs as an example:

Ms. I Wanna Breed is considering breeding to my dog Cayleb (Ch. Po Dusham Ghost of a Chance, FCh). She hasn't spoken to me about it yet but is just beginning to do her research, attempting to determine if this is really the direction she wants to go. One of Ms. Breed's biggest phobias is thyroid problems. She has read so much about it that she is determined not to breed to any dog that might have this problem. She has 'heard' that my dogs are free of this disease but how can she be certain of this? How can she 'know'?

On to the Internet

Ms. Breed logs onto the Internet and heads to the BCOA home page - http://www.borzoiclubofamerica.com/-easily finds the link for the Health Registry and gets ready to search the databases. She decides to first see if I have received any recognition from the BCOA for having my dogs tested. She goes to the Certificates of Good Health Registry and simply types my last name (Avant) into the blank where it says 'owner' and then clicks 'search.'



This is what she finds ...



Well, not exactly what she had in mind, but at least she does know that ONE of my dogs has received a Certificate of Good Health and it is related to the dog to which she is considering breeding. Wanting to know more about the presence or absence of hypothyroidism in my lines, Ms. Breed checks into the OFA Thyroid Database. She simply types the first two letters of my dog's registered name (in this case 'po') into the first blank and clicks `search'
