The pamphlet So You Want A Borzoi answers basic questions about owning a Borzoi. The Guidelines for Breeders of Borzoi is also online.

Two years ago, I would not have guessed that all the members of my local dog club would be "online". When an issue comes up, it is e-mailed to the members. Comments are exchanged and if a vote is needed, we e-mail our vote to the president. The monthly business meetings have been eliminated, saving the cost of room rental, the mailing of meeting notices and our time and gas. AKC Delegate's Report— Karen Staudt-Cartabona

SEPTEMBER 12, 2000 MEETING

ince the majority of the Tuesday Delegate meeting was to be devoted to the Delegates voting on governance by-law amendments to the Constitution and By-laws, Nina Schaefer, chairman of the Committee, was introduced at the morning Delegate Forum. Mrs. Schaefer gave a comprehensive overview of the amendments we were preparing to vote on. She explained "that one of the main reasons behind these amendments was to update the by-laws and to eliminate existing inconsistencies. Other changes were recommended in an attempt to rearrange by subject matter, restructure, retitle and simple housekeeping changes."

She also explained the thinking and desired outcome of the proposed changes. Mrs. Schaefer then went on to give attending delegates a brief overview of the pending by-law amendments.

The quarterly meeting began with the introduction of the officers and the election of the new Delegate Standing Committee members. There were 329 delegates in attendance.

President Al Cheauré gave a brief lecture, parts of which I would like to include here: "competition begins with the breeding of purebred dogs and culminates in our many shows and trials. For those involved in our sport, we want to breed the best dogs, then we want to win with those dogs..." "We want to win but we recognize that winning is only valid if it is done within the precepts of fairness and stability. Winning at any cost is not consistent with our type of competition. If by such winning we denigrate the sport. We truly do



not win."

Mr. Cheauré went on to discuss the Frequently Used Sire program, one of the benefits of which is, many commercial breeding kennels have continued on a sharp decline. They are publicly stating their opposition to the program and are boycotting AKC litter registrations for their dogs. The good news is that they are now down 40%! (Dog registrations in contrast are up 8 % since last year.)

We then went into discussion and voting on the revisions to the by-laws. The discussions and explanations became quite lengthy and at times evoked heated discussions from the floor, as the delegates struggled to understand the exact meaning of what we were voting for. For those wishing to read about these amendments and the discussions as recorded in the minutes, in depth, see the Oct. 2000 issue of The Gazette. It makes for interesting reading. The meeting itself went on to become one of the longest in delegate history. Many delegates who had afternoon flights, were forced to leave before the end of the meeting, This was too bad for the remaining delegates, many who had been patiently waiting to express their opinions in reference to AKC's newly instituted Multiple Sire Program.

The Multiple Sire Program was instituted by AKC after a discussion with the Parent Club Committee and, we were told, a wildlife veterinarian, who advocates multiple sires in wildlife to preserve the species, as the strongest sperm will do the impregnating.

After much discussion with my peers, I find that many are opposed to how this program was adopted, which is my objection. This type of breeding practice could be allowed (with DNA testing and a fine) if a bitch is accidentally bred, or, special permission given on occasions, as needed, perhaps in the case of an old dog who may not be fertile but still valuable, with a backup stud. But the multiple sire program should not be encouraged as the direction for purebred dogs and would indeed, as has been stated, encourage sloppy and careless

breeding practices.

It is also felt that this issue is too controversial and much too important to the fancy for the Board to have decided upon, without it having been brought to the delegate body for discussion and a vote. I did mention these oppositions to the Board during our BCOA conference call. I felt strongly enough about the issue to address the delegate body twice during the meeting. (See AKC GAZETTE Oct. 2000, p. 192 and p. 194.) In part "Breeding dogs is a sport and an art, ... cattle have multiple sires because they are breeding for meat and for money."

Delegate Quarterly Meeting A straw poll vote was called for and then rescinded when it was realized that fully one half of the Delegates had already left the meeting. Since this meeting a proposal has been enacted to bring this to Delegate discussion in December.

As we left the meeting we were given a thick packet of proposed amendments to study and review (with our club officials) to be voted on at the December meeting.

To be included in the "Top Ten" lists for AKC trials and for ASFA trials, the first owner's name listed in the publication (*FAN* or the AKC *Awards*) must be a current member of the Borzoi Club of America. To calculate points: the dog gets one point for itself and one point for each dog defeated in its stake. The dog who wins BOB, by winning the runoff or by forfeit, gets additional points equal to the number of dogs in the other stake. No extra points for BIF. I was so very proud and excited to announce that 28 people had participated in the Records Section of the Registry, sharing facts of both longevity as well as certain health difficulties. I was ecstatic about the fact that the Health Registry Committee had issued 28 Certificates of Good Health and people were ACTUALLY participating—this idea was going to fly!!

Let me share with you where we are today. In just a year the level of participation has more than doubled. Fifty-six individual dogs have been listed in the Health Records Section of the Registry. Over ONE HUNDRED Certificates of Good Health have been issued to our Borzoi: 22 Gold Certificates, 21 Silver Certificates, and 70 Bronze Certificates. One can only say WAHOOOOOO! and THANK YOU! (I just have to stick in a reminder about renewals here—hips count forever; the rest need annual renewals for updated certificates.)

The nay sayers have been few and the supporters many. Numerous breed clubs around the United States and overseas are beginning their own Health Registries using BCOA's Registry as their blueprint. The Canaans are in the talking stages; the Irish Wolfhounds are in the doing stages; and it is all because of US—Borzoi owners who were willing to take a chance and SHARE WITH OTHERS!!
