CANINE HEALTH FOUNDATION CONFERENCE OCTOBER 20 & 21, ST. LOUIS, MO

A synopsis provided by Gary E. Nash DVM, BCOA Membership Liaison

et me begin by stating that the 2001 AKC/CHF Conference was one of the best seminars I've ever attended. The AKC/CHF and Ralston Purina are forging ahead to keep us up to date on subjects that are wide-ranging. These include DNA, cancer research, autoimmune disease, endocrine disease, bloat and a myriad of others.

DNA, for instance, is the milestone many of us have been looking for. Although the experts disagree somewhat as to the merits of cheek swab vs blood sample, they feel the 300 markers obtained by cheek swab are adequate for most studies. BUT a blood sample in which they can find 1000 markers will give us more pertinent exact information down the road.

On the cancer front, there is a study forming which combines research from FOUR different cancer types into one intense research project. These are funded by the CHF, corporate donations and Ralston Purina funding half of the cost. The total cost is several million dollars!!

There are programs proposed by CHF and Ralston Purina that will help clubs add funds to their donor advised fund by providing matching funds for futurity nominated litters and for dogs who were nominated and finished their AKC championships. There will be a weight circle program that will benefit clubs

and owners incorporated in the above mentioned item. All this information will be available in an online chat room started by CHF and Ralston Purina, with times to be announced in February 2002. The topics will cover current research projects as well as breed specific health problems.

I have also informed Virginia Jones, our BCOA Health Chairman, about the CHIC program, which is a national health registry, open OR closed per our designation. I feel it is absolutely essential for us to make use of it. It is structured by the breed clubs and maintained by AKC/CHF.

In conclusion, the only complaint I had regarding the conference was that the question and answer times were very short. However, that was understandable due to the tremendous amount of material presented and the astounding information obtained.

My thanks to all for choosing me to attend this invaluable conference.§

The fall season was a very busy one for the Health Committee. We welcomed three new members, Dennis Williams, Rlynn Shell and Lydia Pruett. Dennis is our 2003 National Seminar & Clinic Chairman, Rlynn is our Health Website Webmaster and Lydia has offered to help out where ever needed! We offered a microchip and DNA swab clinic in conjunction with the BCOA supported show in Fort Wayne, Indiana. We chipped 5 dogs at a very reasonable rate to our participants and swabbed one dog at no charge. Local clubs holding BCOA supported shows in conjunction with their specialties are encouraged to contact the health committee if they are interested in holding health clinics at these shows. We will do everything we can to support your local membership!

The AKC held their National Parent Club Canine Health Conference in mid October in St. Louis. Dr. Gary Nash attended as our BCOA Health Committee representative and was extremely impressed with the depth of information provided by the Canine Health Foundation (CHF) and guest speakers. A significant focus for many of the lecture topics was the important role that DNA marker research has played in many, if not most, of the current research studies being performed. DNA research is creating a strong foundation tool for breeders use when making future breeding decisions. The CHF currently has numerous research studies underway. One of these is a DNA research projects is to determine if there are any common markers amongst any and/or all breeds of dogs. Determining common markers among breeds can help to expedite current and future research in genetics and their association with the particular inherited diseases under study.

The Ralston Purina Company provided information on a new program they are offering to Parent Clubs to help support their CHF research projects. This



program is called the Purina Parent Club Partnership (PPCP) Program and is an alliance between Ralston Purina Company and the AKC recognized National Parent Breed Club to promote canine health and well being. Current Pro Club members can designate one parent breed club as the recipient of this program. They will have their pro club weight circle points matched with funds donated to that parent breed club. When the parent breed club donates these funds to the CHF Donor Advised Fund they will be matched by the CHF. All points earned by Pro Club members will still be credited to that member's account for their personal use. PPCP is an incremental program to Pro Club members. Purina is running this program as a trial from March of 2002 to the end of December 2002. At this time, the BCOA has decided not to register with the PPCP as a participating parent breed

club because of certain restrictions preventing us from accepting support from other sponsoring corporations. We hope Purina will reconsider this stance if they intend to extend this program into 2003. 2002 NATIONALS SEMINAR & CLINIC INFORMATION

This year's clinics offer the membership some incredible price breaks on clinic costs thanks to Eddie Dzuik, CEO of OFA and the services of our Health Committee veterinarians, Dr. Bill Norelli and Dr. Gary Nash. OFA has offered us a price break on both thyroid and heart registration with the OFA. The registration fee for these clinics will only be \$10 instead of the usual \$15. There is no re-certification fee, only the examination and lab fees. OFA has also offered our breed club to participate in a health certification challenge! What does this mean? We have set a goal of registering 100 borzoi for thyroid and heart clinic participation at the Nationals. If we meet or beat this challenge, OFA will donate an amount to be specified later to our CHF Donor Advised Fund! This is wonderful news and a great opportunity for our club to earn additional funds for our pending borzoi health research project! With entries at the Nationals well over a 300 dog entry, I'm sure we can meet this goal! All dogs must be permanently identified by either microchip or tattoo in order to participate in the eye, thyroid or heart clinics. If your dog is not permanently identified and you want to participate, attend the microchip clinic first! We will be using Home Again microchips at this clinic. All dogs will be scanned or tattoo number recorded at the time of examination for any of these clinics.

PLEASE REMEMBER TO BRING WITH YOU TO THE NATIONALS A COPY OF YOUR DOGS AKC REGISTRATION CERTIFICATE.

The registration numbers of the participating dog's sire and dam need to be included on the OFA & CERF registration paperwork. Do NOT forget to bring these papers with you! There will be a registration sheet to sign up for clinic time slots at the Health Committee table. If at all possible, please register in advance for a particular time slot. We will do everything we possibly can to accommodate your very busy schedules. Here is the complete schedule and associated fees:

MONDAY, WEDNESDAY & THURSDAY AFTERNOONS:

- Microchip clinic with Home Again chips \$25 includes chip, implanting AND reg-
- Thyroid clinic \$55 includes exam, lab fee and OFA registration
- DNA swab clinic no exam fee, \$40 AKC registration fee

• CERF exam - \$22 exam fee, \$10 fee for initial registration or \$7.50 fee for re-registration

WEDNESDAY AND THURSDAY AFTERNOON:

• Heart clinic - \$25 exam fee, \$10 for initial registration with OFA, re-registration is

THURSDAY EVENING:

• Seminar speaker Dr. Fayer-Hosken will provide information on tools and concepts to improving the potential for successful matings. The seminar fee is \$10

So, what can you expect from your health committee in the future? The next step for us is to begin putting together materials and plans for another breed survey. We plan to take advantage of offering both an on-line survey or a hard copy survey form for those members who do not have computers with Internet access. The ease of entering data into a simple on line form should allow a significant improvement over the paper form both with ease of entry for participants, data collection for the research evaluation team, and minimizing postal fees for both outgoing and returning surveys. Look for more information regarding our upcoming breed survey in the near future. A proposal will be drafted and submitted to the AKC/CHF requesting a review of the BCOA Donor Advised Fund heart research project. The AKC/CHF will then review the request, determine if we have a viable research project at that time, review the potential to join with other breed clubs of similar research criteria, recommend who might be best qualified to conduct the research and provide us with estimated costs and next steps for the specified research requested. Research studies involving a broad spectrum of heart diseases can be a significant expense. While teaming up with other breed clubs can certainly help defray some of these costs, we should anticipate that far more than our initial \$10,000 and the CHF matching fund will be required before we will be able to begin this project with earnest. The committee will be looking for fund raising and partnering opportunities on a regular basis to help embellish our foundation pledge. Suggestions are always welcomed.§
