Standing Rules [KC Artley]

The 2 standing rules, from 1982, (M21 & M22) dealing with eligibility of dogs owned by a show chairperson to be exhibited at our Specialty, were moved to the History file. This is the replacement standing rule: "Dogs that are owned, coowned or reside with the show chair, or co-show chair, and/or members of their immediate family may not be exhibited in the conformation classes (futurity, sweepstakes and regular classes). Show chair, co-show chair, and any person residing in the same household as the show chair or co-show chair, shall not exhibit or act as agent or hander, in the conformation classes at the Specialty."

AKC Meet the Breeds - Florida

On-line Shopping Cart (KCA) After research, and discussion with Lynn Shell, KC Artley recommends that we implement Helen Lee's proposal. ROM & Health Committee - proposals for links, CHIC requirements

The Board discussed the ROM Committee's and the Health Committee's proposal, tabled from the August 2012 meeting in order to get input from members. Both committees want to change the ROM Listing on the BCOA website to

note (via a hyperlink) which sires and dams have their health test results displayed on the OFA database. Also, the committees propose that in the near future, all dogs be required to have a CHIC Number in order to be eligible for ROM participation. A motion was made by Robin Riel, seconded by Lorrie Scott, not to approve. Passed.

The Board agreed that the purpose of the ROM program is to recognize the achievements of the offspring in conformation and performance, by awarding a ROM title to the sire and dam. Whether a borzoi has passed health tests is a separate issue. The Board supports health testing for borzoi and encourages the submission of test results to OFA; however, the Board also acknowledges that breeding is a balancing act that includes each individual borzoi and many relatives in its pedigree. Along with health clearances, a breeder must evaluate the temperament of the borzoi and consider how well the borzoi fits the breed standard. Also, health problems such as bloat/torsion, cancers, epilepsy, auto-immune disorders, and other conditions for which there are currently no tests must be factored into the decision. Consenus of the Board of Governors: Health & Registry of Merit are, and of right ought to be, separate.

National Specialty Health Clinics: The Health chair has the authority to fill vacant Exam spots after entries close at a fair market rate. The Show Secretary will inform the Health Clinic chairperson of how many borzoi are signed up for each health clinic, as soon as possible after entries close. The Health Clinic chairperson is responsible for letting local dog owners know that any breed can be tested at our Health Clinics by paying BCOA's cost for the test. The reduced rate for the Health Clinic, paid for by the BCOA Health Fund, is only available to borzoi, that are registered before entries close. Motion: Prudence Hlatky Second: Joyce Katona PASSED

Aristocrat Options (Joy Windle)

Proposed that BCOA will publish & mail to the members a printed, color *Aristocrat* quarterly. Ads are needed to pay for this magazine. It will be available by subscription to non-BCOA members. The budget is \$12,000 for the first four issues. If the cost exceeds \$12,000, the Board will consider whether to continue publication and must approve additional funding. Motion: KC Artley Second: Barbara O'Neill PASSED.

Annual Versatility Award

A committee was formed in May to consider whether to add any of these new AKC titles to the Annual Versatility Award (AVA), plus recommend what points each new title should be worth. The AVA committee's report was tabled at the August meeting, in order to get input from members who participate in obedience.

- 1. Approve the committee's recommendation to add the Grand Champion (GCH), bronze GCH, Silver GCH, Gold GCH and Platinum GCH tiles to the AVA, with each GCH title worth 15 points. Motion: KC Artley Second: Prudence Hlatky PASSED.
- 2. Approve the committee's recommendation to add the Graduate Novice & Graduate Open & Versatility titles, with each title worth 15 points. Motion: KC Artley Second: Prudence Hlatky PASSED.
- 3. Approve the committee's recommendation that the multiple UDX titles (UDX2, UDX3, etc.) be added, with each title worth 40 points. Also, add the Obedience Masters titles, with each title worth 40 points. Motion: KC Artley Second: Joyce Katona PASSED.
- 4. The committee's recommendation to reduce the Beginner Novice title from 15 points to 3 points was not approved. Motion: KC Artley Second: Lorrie Scott PASSED. The Beginners Novice title is not a new title; it is already in the AVA program, and will continue to be worth 15 points.

Obedience Ranking criteria (KC Artley)

After consulting with members who participate in obedience, the following two standing rules were passed to document how statistics for obedience/rally will be compiled.

- 1. "The obedience statistician will keep scores for all member owned borzoi earned in the regular & optional titling obedience and rally classes. If the dog has more than 1 score in that class, the scores for that dog in that class will be averaged. Lists for each class will be compiled to rank the dogs from first, to whatever placement includes all dogs that competed in that class. Scores in the "A" and "B" classes will be combined; for example, scores from open A and open B will be published in the list under just Open. These lists will be published in the *Aristocrat*."
- 2. "For the annual award of #1 obedience dog, only scores from the obedience-novice, open, and utility classes will be used. The dog must have earned at least 3 scores in these classes. (For example, a dog could have 2 scores in novice and 1 score in open). These scores will be averaged, with the highest average awarded the #1 borzoi, BCOA member owned, for the calendar year." Motion: KC Artley Second: Prudence Hlatky PASSED

Election: There being no write-in petitions submitted, President Peters-Campbell directed Recording Secretary Windle to cast one ballot to elect the proposed slate of Officers & Regional Governors. The following were elected:

Good Sportsmanship Award

Standing Rules regarding Awards.

The standing rule, C5, dealing with a good sportsmanship award and awarding certificates to top 10 dogs in conformation and obedience was moved to the History File, and replaced by the following two new standing rules:

1. **Good Sportsmanship Award** "Each year, the Board should consider, whether to award the AKC Good Sportsmanship Medallion to a member at the National Specialty. This medallion should only be awarded for exceptional service to the breed and to this club over a long period of time. It is not required that this award be made each year." Members who have been awarded the AKC Good sportsmanship Medallion in the past, are Ginger Jones (2007), Karen Mays (2008), Shen Smith (2009), Barbara O'Neill (2010) and Patti Neale (2011).

Motion: KC Artley Second: Prudence Hlatkey PASSED

2. Publication of Top Dogs: Publish the final results for the calendar year in the *Aristocrat*. Publish the names of the TOP-10 dogs in the following categories: Conformation, ASFA lure coursing, AKC lure coursing, open field coursing, LGRA, NOTRA, and the Obedience and Rally classes. In addition, the TOP-5 dogs that qualified for the Annual Versatility Award will be published. Further, the TOP-5 juniors in Junior Showmanship should be published. Motion: KC Artley Second: Barbara O'Neill PASSED. (Note that all these dogs have to be owned by BCOA members. The top junior has to be a BCOA member, but the other 4 juniors do not have to be BCOA members).

Rescue. The Board discussed the use of BCOA Rescue funds to reimburse money spent on behalf of member-owned dogs due to emergency situations. The concept was approved in principle. Rebecca Peter-Campbell will coordinate with Dee Jones and will report back at the next meeting.

Beverly Taylor Trust Committee

Lorrie Scott has resigned from the committee.

The Board regretfully accepts Lorrie's resignation & approved Barbara O'Neill as her replacement.
