- AKC Heritage Preservation Bank Amy Sorbie

Amy described the AKC Preservation Semen Bank purpose. Parent club will decide how the semen is appropriated. BCOA has elected to be part of this program. The committee was established and is in the process of determining the criteria for application to use the semen. Stephanie Parker Infinity Semen bank was chosen by AKC to be one of the banks for storage for the program.

- Submitted Topics from the Membership

Limit National Specialty sites to 2 or 3 locations. Suggestions were Wilmington OH, Estes Park, CO and maybe Asheville, NC.

The Board has been taking this into consideration for some time now. The Board is forming a committee of the Specialty Coordinators to review and make recommendations.

- Anne Midgarden discussed opportunities to improve specialty field events in her location in Ohio.
- Barbara Binder expressed concern (via a letter to Kay Novotny, her Regional Governor) for content on the judge's trifold. Requested adjustment regarding description of teeth and plush coat.
 - Patti Neal described that the trifold was based on the illustrated standard which describes the coat that returns to bitches after their seasonal blow being a short but very soft and fine coat and that more importance should not be placed on teeth than any other requirement for the borzoi breed.
- (Renee McCartin)

Ron, I'd like to add something to the agenda to the membership meeting that we look at possibly changing our performance events to make them more profitable or at least not as expensive for the club.

The Board is proposing an exploratory committee to address the following recommendations:

- 1) Change events to all breeds to bring in entries. We do not need to do big awards for other breeds, rosette for BOB, flats for placements.
- 2) Contact a local club in the area and get an event planned for that weekend where we only have to worry about sponsoring the Borzoi entry. They run the event, pay the field fees, pay the judges, and we are just out trophies.
- 3) In KY we ran LGRA and a coursing event on the same day. LGRA in the morning, coursing afterwards. Texas clubs often run ASFA in the morning, and AKC in the evening. That way we only need the field for two days versus three.

- 4) Cancel whichever coursing event pulls the smallest entry. Cuts down on one day of the event (or two if we stick with just Borzoi events and do LGRA in the morning and coursing in the afternoon), and thus cost of field rental.
- 5) Add FastCAT after one of the events. (Maybe racing as the field is set up, just have to shorten it, but it means investing in timing equipment.
- 6) Allow gate entries. There's no reason to have pre-entries for coursing/racing be a month ahead of the event. It's quite easy to have the entries close the Wed before and the secretary get everything together. For our area, the first AKC event of the year is the first weekend in April. The first LGRA had nasty weather and nobody came out, 2nd was cancelled due to the weather in your area this last weekend, the 3rd is the weekend after closing date, If you have young dogs that are now old enough to run, you don't have a chance to cert them prior to the nationals, thus losing out on entries.
- John Steele requested a budget report for National Specialties by event.
 Barbara Danieli indicated and agreed that this should be done going forward.
- Kristen Lord and Valori Trantanella requested that they be allowed to advertise their specialty as well as any other club at the National Specialty.
 Renee McCartin also recommended that the clubs advertise their specialties in the Aristocrat.
- Karla Smith inquired if the Club had plans for an audit. Lyn Snyder Hoflin responded that several firms were contacted and the lowest estimate for a full audit would be \$13,000 - \$14,000. A review would run around \$8000 - \$9000. The Board plans to have a review done and is looking into more affordable options.
- Tina Wismar DVM raised a concern about why the Board changed the CHIC requirements.
 Julia Merriman raised a concern for lack of transparency regarding the Boards' handling of the change and felt that there was not sufficient communication to the membership.
 John Steele conveyed that the process the Board took was appropriate and the procedurally correct method.
- Stephanie Parker asked how to become involved in the committees or as a committee chairperson. Kim Horn Janek offered the membership should review the website for information. Barbara Danieli reminded members that social media is not the correct place to go to for accurate information on what is transpiring in the Club, unless it's the Official BCOA Facebook page, BCOA IO Group or posted BCOA Board minutes. She recommended contacting Regional Governors or Officers of the Club with their concerns and recommendations.
