The number of ballots cast 256. Number of invalid ballots was 1. The number required to elect is 129. Here are the results: Eduardo Fugiwara, 114; Dr. Charles Garvin, 198; Steven Hamblin, 183; Daniel J. Smyth, 167.

Amendments to be Voted on at the June Delegate Meeting:

A proposed amendment to the Charter and Bylaws of The American Kennel Club, **Article VI, Section 6**.

This amendment is to the Charter and Bylaws of The American Kennel Club, Article VI, Section 6, removes the reference to professional judges (one who charges a fee in excess of expenses) as it relates to Delegate occupational eligibility.

AKC Parent Club (PC) Items of Interest for BCOA BOD review

Independent Specialty RW 3pt Major (See Backup Materials):

3 pt Reserve winners at regional specialties. Criteria 2x number needed for a 5pt major.

If two opportunities for championship points exist, even at these heightened requirements, it might encourage people to enter more shows. And as others have noted, it is my understanding that the regional clubs would still need permission from the parent club to offer points to RWD under these circumstances.

Breeder Judges: – AKC List (See Backup Materials):

Judging Operations is formulating a list of breeder-judges for all AKC recognized breeds. The list of breeder-judges for each breed will be published on the AKC website, available for users to print and/or download.

Junior Showmanship

The Canine Partners Program has been discontinued due to lack of interest. The Canine Partner's program was the allowing of Junior exhibitors to show All-American dogs in Juniors competition.

<u>Superintendents and Specialties</u> (See Backup Materials) - A statement AKC obtained from superintendents stating that, going forward, they will continue to fulfill existing contracts for National Specialties but will no longer service them.

<u>Parent Club Best Practices</u> (See Backup Materials) <u>– A</u> series of webinars highlighting some of the important elements of each of the subjects the Best Practices committee has been created. These have proven to be excellent seminars and are open to everyone. BCOA members were sent information and reminders of these webinars. When available the links to the presentations will be shared. Webinar dates are in the backup materials.

Parent Club Breeder's Development:

EDDY Award: The first EDDY Awards will be presented in December 2023. The deadline for applying for this award is September 1, 2023. AKC will begin accepting application forms on June 1, 2023. The link is: www.akc.org/breeder-programs/breeder-education/akc-eddy-award/

Breeder Education Coordinator: Committee still working on the Suggested Guidelines for Establishing a Breeder Education Coordinator. These will be sent out to all PC in the near future. <u>AKC Purebred Preservation Bank:</u> A survey will be sent out asking Parent Clubs their opinions about this project and why or why not they will support/use it.

The AKC Parent Club Health Conference will be held both live and virtually in St. Louis between August 11-13, 2023. Registration is not yet open.

Donation documents are almost complete. They will be available via a downloadable pdf. The form will require the following information:

- There will be three levels of information that donors will be asked to submit:
- 1) Donor Application and Semen Profile, which contains generic demographic information about the sire and semen
- 2) Genetic Material Donation Agreement released the PPB from liability
- 3) Breed specific information determined in consultation with Parent Clubs

Should a breed have any known genetic issues, the PPB can ask potential donors if the donation might be from a dog who has such genetic issues. It's cautioned that when the PPB begins accepting donations, there will be some donations that meet all of the current testing criteria specified by the club but the older donated straws oftentimes will not have the complete battery of required tests completed because they didn't exist when the sample was originally taken.

Semen that is unfit for breeding may be donated if the straws contain known genetic issues that can make them useful for other (not breeding) scientific research.

AKC Board Purebred Preservation Bank action

Following a motion by Mr. Hamblin, seconded by Mr. Powers, the Board VOTED (unanimously) to amend the Board Policy on Purebred Preservation Banks to read: The AKC encourages all Parent Clubs concerned with preserving and protecting their breeds to collaborate with the AKC Purebred Preservation Bank (AKCPPB) and/or establish their own Parent Club sponsored frozen semen bank. The signatories of the AKCPPB may sign as semen owner on all relevant AKC Registration documents and applications, including litter applications. A Parent Club sponsored, breed specific, frozen semen bank may, with AKC Board approval, also be allowed to sign as semen owner on all relevant AKC Registration documents of each Parent Club. However, Parent Clubs collaborate with the AKCPPB is solely the decision of each Parent Club. However, Parent Clubs seeking to establish their own such entity must petition the AKC Board via letter signed by the club's current president. The letter should explain the club's purpose for establishing the bank and acceptably document its incorporation and organizational relationship to the petitioning Parent Club. Upon Board approval, the bank must provide AKC with a listing of signatories for use in AKC Registration matters.

All-Breed Committee – good news, bad news: Once again Group realignment is being considered. <u>Group Realignment Subcommittee report</u>. Laurie Maulucci advised that since the Subcommittee had been formed by the Coordinating Committee, and key members Subcommittee Chair Rita Biddle and Coordinating Committee Chair Cindy Miller were not able to attend, the report will be presented in June.

Independent Specialty RW 3pt Major

Please see the attached memo regarding the 3 pt major reserve. As Red described this has been a topic of discussion at the Board. We are asking for your committee to review and let us know their thoughts and opinions on this topic as the original proposal of the option of a 3 pt major reserve at National Specialties that met the entry requirement came from the PC Committee.

We realize your committee's time has been shortened but hopefully you can share this memo with your board members and open up the discussion and provide feedback to Michael and I.

Thank you, Ann and Michael AKC Board Liaisons Parent Club Committee The Board has received a request from an independent specialty to club to grant them permission to award a three point major to their Reserve Winners Dog/Bitch since their class entry normally exceeds two times the number required for a five point major in their division. While the board is still contemplating this request the discussion has led to an alternative for consideration.

The alternative to granting this to just a single specialty club is to consider changing the rule so that it would apply to all specialties where the class entry is equivalent to two times the required number for a five point major. Staff took a look at the events in 2022 (excluding any National Specialties) to determine how many times there was an entry of two times the number needed for a five point major. From January 1 to November 11, 2022 there were 125,796 exhibits awarded Reserve Winners at all events. Of those, 416 instances (0.3%) were in entries of two times the five point major number. 121 different breeds made up these instances with 45 (37%) being low entry breeds. The instances were distributed across 144 all-breed shows, 33 group shows, 143 parent specialties and 96 specialties. 60% of the time it was an event in conjunction with a National Specialty. So the net occurrences for specialties would be 239 times.

The Board would like you to seek the opinion and comments from the DSR committee at the March meeting, if possible. Since this potential change also affects the Parent Clubs I am forwarding this letter on to the Parent Club Liaisons so that they can seek comment from the Parent Club committee as well.

I hope this finds you well and look forward to the March meeting in Newark.

Breeder Judges: – AKC List

Dear Parent Club,

Judging Operations is writing to inform you of an initiative it shared with the AKC Board of Directors at a recent meeting and at the March 2023 Delegate Parent Club Committee meeting. Utilizing AKC's registration and judging data, Judging Operations is formulating a list of breeder-judges for all AKC recognized breeds. The list of breeder-judges for each breed will be published on the AKC website, available for users to print and/or download.

Our hope is for clubs to utilize this information to assist in their selection of judges, and when determining specific breed assignments. Use of breed specialists on judging panels is one of the ways clubs can explore to enhance their events and draw additional entries.

To identify breeder-judges, criteria which parallels the requirements for an individual applying for conformation judging approval as a New Breed applicant (1st time) in that breed is being utilized (litters bred and champions produced). Once finalized, AKC conformation clubs will be informed of the availability of the list of breeder-judges for all breeds and educated on the benefit of using breed specialists on their judging panels. Staff will periodically revise the listings based on new judge approvals and updated registration data.

We are writing to each parent club asking them to share any list of breeder-judges they may maintain for its breed as we recognize some individual's experience may pre-date AKC's electronic records. The parent club list will also assist in mitigating the omission of

qualified individuals. If your club does have a list of breeder judges to share, that list may be forwarded to the Judging Operations Department at judgingops@akc.org.

Parent Club: Specialties and Superintends

Peter Piusz for Karen Burgess – Peter read a statement AKC obtained from superintendents stating that, going forward, they will continue to fulfill existing contracts for National Specialties but will no longer service them. Many of the clubs are extending their shows over several days which removes the licensed superintendents from being able to service sometimes as many as two other shows. It is not economically feasible for superintendents to continue servicing these multi day Nationals when more lucrative all breed events are available. This problem is exacerbated by parent clubs continuing to schedule non-standard events that take additional programming time for the superintendents. In addition, they are now seeing an influx of newly minted show chairs who have received no training from their predecessors and are left adrift without the basic knowledge necessary to successfully run their event. They turn to the superintendents for help which makes it more difficult for them because of the additional time required to teach them their jobs. It's to the point where they spend more time and resources on smaller National Specialties than any more lucrative all breed shows. Harvey Wooding indicated that he and Karen will be putting together some informational papers for distribution to parent clubs which will lend some clarity to the situation and discuss some possible solutions. A letter reprising the issues Peter discussed will be sent to the PSD email group. Connie Butherus said it was her understanding that the superintendents will still continue to do packaged shows.

AKC Lifetime Achievement Award (Conformation, Performance and Companion)

In its endless pursuit to recognize outstanding members of the fancy, The American Kennel Club Lifetime Achievement Awards were created and first awarded in 1999 to honor our best. The purpose of the awards is to celebrate those individuals whose many years of dedication have led to significant contributions to our sport. Recipients have greatly advanced the sport of purebred dogs through their dedication including breeding, exhibiting, judging, teaching and club involvement.

Nominees are selected by AKC Parent clubs who cast their votes for one nominee in each of three categories: Conformation, Companion Events, and Performance. The three submitted club nominees receiving the most votes in each category were selected as finalists. Member clubs are then asked to cast their vote for one nominee in each of the three categories.

Borzoi Club of America submits our nominee for each category. Since our nominees seem to not have a chance to be selected, we thought it would be appropriate to publically honor them. This award celebrates the distinction, integrity and commitment of the recipients.

Standing Rule AWD2: Each Regional Governor will contact their area members asking for suggestions and a letter of recommendation detailing why that person should be considered for this honor. The Governors will forward these recommendations to the Recording Secretary in time for the first Board meeting of each year. These areas of nomination will cover Conformation, Companion and Performance. It was noted that the BCOA nominees are from the ranks of BCOA members only. The Board will decide on no more than one nominee for each area, and does not have to make any recommendation. The corresponding secretary will forward the names to the AKC.

Starting in 2016, a gift of a silver Borzoi pin, sponsored by Kyoko Ozeki, Japan, to the yearly Board selected nominees.
