Greetings BCOA-BTRC, BCOA Board of Directors and the Support Staff,

Just to update everyone with a quick report on the "State of the BCOA-BTRC Schwab Accounts" since the 1st Quarter report of 2023. Attach for your review are the 2nd Quarter Schwab statements for RescAcct#1 & #2 zipped for your files. At this point in time (through the 2nd Quarter of 2023) there have not been many improvements in the economy in fact with the Feds planning more interest rate hikes this September the economy will still be declining at a serous rate. The 2022 year was one of learning for the BTRC on how to exist and still accrue income in markets that did nothing but decline. There was earned meager income in 2022 and the BCOA-BTRC was able to disburse \$5000.00 to rescue benefit from the \$22.000.00 net-net earned last year.

There really isn't better news to report right now, but following the last BTRC meeting in the 1st Quarter of 2023 it was decided to split up some of the major funds retained as cash-on-hand within the two rescue accounts and to go ahead and spread some of that cash out through more investments in the certificates of deposit market and less investment into the lackluster bond markets. The CD's purchased with the BCOA-BTRC cash-on-hand funds earlier this year are earning a nice 5+% and the fund investments (old and new) are invested only in premium rated companies and all covered by FDIC insurance. There will be a more in-depth report following the Fall/23 BCOA-BTRC Budget meeting.

13. Futurity – Lydia Pruett

14. Health - Virginia Jones

The Health Committee met in total on April 6th where we discussed each team's progress to date on the plan we reviewed at the previous meeting. All committee members were present. We spent some time clarifying the expectations of each team and established a plan for meetings with each individual team with one monthly follow up meeting with the entire team. I shared information with the Committee on the Morris Animal Foundation Grants Review Meeting that I had attended and followed up by arranging for them to be able to hear the recordings from the 2-day event and forwarded the link to the recordings and the Non-Disclosure Forms that would need to be submitted prior to the link being activated for them. We also discussed the upcoming Canine Health Foundation Parent Club Conference and dates. Karla indicated that she was planning to attend in person, and I would attend virtually. Because of date conflicts, no other members were able to attend. (Notes from the conference held August 11th, 12th & 13th follow below under Research Team Update. Additionally, I've contacted Andrea Fiumefreddo of the Canine Health Foundation to schedule a follow-up meeting to discuss our research interests. I contacted Monica Henderson, AKC DNA Program Research and Development to request kits for the Genetic Diversity program to provide at the 2024 National in Olympia Washington, but the timing did not support their objectives to have all kits returned by the beginning of September of 2023. Information regarding the program was posted to the Members IO group.

• CLINIC TEAM UPDATE:

I met with the Clinic Team, Caryl Dumaine, Kristi Arnquist, DVM and Karla Smith, DVM on June 26th and we discussed plans for the clinics for the 2024 National Specialty in Olympia, Washington. The team will move forward contacting Cardiologists and Ophthalmologists in the area and determine the availability of Specialists and their fees and we will meet again once they've successfully found both or either of the Specialists. At the time of this writing, we have an Ophthalmologist, but he is only available on Friday. I would need to know if this day would be available for us to offer this clinic. If not, the team will continue to look elsewhere. We do not yet have a Cardiologist confirmed. We also discussed updating the process for the Holter Rental program on the BCOA website and Caryl will follow up with me on how this look and function on the website. We discussed providing advertising for Regional Clubs who are sponsoring a

clinic at their Specialties or large Cluster weekend shows. I sent a request to all Regional Governors to cascade this information to their membership and for the Regions to get back to me with the dates, times, locations, and prices for their clinics so that we can put these on the BCOA website and also broadcast the information on the Members IO groups. I'm currently working with Caryl on getting the Fall BCGO clinic information ready to post on the BCOA website.

• INFORMATION TEAM UPDATE:

Next step is to meet with the Information Team, Karen Klein, PhD and "TBD", to follow up with their ideas for reformatting the entire BCOA Health website. The complexion of the Information Team has changed with the resignation of Justine Spears. I will be looking to add members to the Information team that have website and Facebook skills to manage the development and maintenance of both. Our immediate focus will be to start constructing a well-thought-out, user-friendly website that functions seamlessly from page to page. Once this is completed, we will focus our attention on the BCOA Health Facebook page. If any member has an interest in joining this team, please feel free to contact me.

FUNDRAISING TEAM UPDATE:

A meeting with the Fundraising team, Anistasia Hester, DVM, and Kristi Arnquist, DVM, will take place before the end of this month. I've provided them with some ideas and asked them to think outside the box about potential fun projects we might entertain. We need to start moving forward with projects to offset clinic and seminar expenses as well as reinforce our research funding. Setting goals for expected income and focusing on just one project at a time will help drive the team forward.

• RESEARCH TEAM UPDATE:

After reviewing the outline of the task provided to the team, Karen Klein, PhD, has declined her position on this additional team as she feels her work and life schedule cannot support the demands of both teams. Instead, she will focus on providing articles of research and health interest periodically for the Aristocrat publication as part of the Information Team, beginning with the Winter publication. The team now consists of Karla Smith, DVM and me but we will be utilizing input from our entire committee at our total Committee Meetings.

15. Health Foundations – Virginia Jones

Two items of significant importance have transpired since our first meetings:

First:

I had the opportunity to attend the Morris Animal Foundation Grants Review Process Meeting for Hemangiosarcoma research. It was an absolutely amazing experience to hear so many proposals being put forward by the best and brightest candidates for consideration and to learn how the process for analyzing the proposals was undertaken by the Scientific Advisory Review Board panel. For canine research, Morris Animal Foundation has prioritized their number one canine objective for this year to be a single focus in making advancements in Hemangiosarcoma research. From the list of over 36 submitted proposals, they hope to be able to select and fund 6 projects with the most impact on this cancer, and have approval for them to move forward by the last quarter of this year. More news will be forthcoming on this initiative.

Second:

Both Karla Smith, DVM and I attended the 3-day Canine Health Foundation Parent Club Conference the weekend of August 11th through the 13th. There was a total of 12 presentations provided in the categories of Immunology & Microbiome, Preventative Applications, Treatment Applications, and Progression Towards Cures. Of special interest to the Borzoi breed was the study on the Development of Genetic Tests for Sighthounds: Anesthetic Drug Sensitivity and Delayed Postoperative Hemorrhage (DEPOH) provided by Dr. Michael Court, Washington University. The 2023 Asa Mays, DVM Excellence in Canine Health Award was awarded to Dr. Gary Johnson of University of Missouri, and presented by Eddie Dziuk, OFA CEO. Dr. Johnson provided an in-depth overview of his life's work with genetic research. The news release in its entirety will be provided on the Members IO page and in the Aristocrat fall publication.

18. Membership – Kelley Frary

Ginger and I have had several ongoing discussions to improve some past practices:

1. A comment I've heard a lot of from members is how arduous the process is to become a member. One slight improvement might be made in accepting digital signatures on applications. Digital signatures are widely accepted in contract law these days and a standard practice in the industry I work in which is real estate. My feeling is if you can sign a multi-million dollar purchase agreement electronically, there should be no reason why a membership form would need more formality with a wet signature. For many of the applications that are ready to be submitted minus a missed signature here or there,

this would speed up the process of getting the membership application across the finish line. I know this topic had been discussed some years ago, and I'm just wondering the logic behind not accepting them. For the recording secretary and membership coordinator, this would significantly reduce the labor of chasing down applications if we had the option to do this. I think it's a topic worth revisiting given the advancements we are making in technology and as the age base of our membership shifts over the next 10+ years.

- One other way to streamline membership might be to integrate our application onto the website. Many national clubs currently are doing this one example being: https://dpca.org/club/membership/
 While I understand the concept behind prospective members following directions, filling out the application, waiting for readings, etc. It's a process that may disenchant younger members and seems incredibly involved in comparison to other clubs. I think streamlining the process a bit will make for a better end user experience and we can still have the same checks and balances in place with the required readings and sponsorship requirements. I think the goal should be to work towards a more cohesive-easy process and moving to a digital format would award us that and likely avoid less errors on the application that take months to get corrected. I know of a couple people who I feel would be valuable members to the club, and looked into BCOA membership, but were disenfranchised with the process so have not yet applied.
- 3. Membership Booklet- I'll be taking over editing of the membership booklet for Helen to make her life easier. I know it's been discussed that our policy will change at the end of the year, that if dues aren't paid by December 31, then they will not be listed as active members in the membership booklet. My thought is that I can reach out to governors around early October to send a reminder out to their constituents to ask for updates on their contact info. That way, we are getting ahead of the curve early and hopefully getting those updates earlier in the year. The goal is to have the membership booklet sent to the printer no later than January 15th and hopefully booklets printed no later than January 31st in a perfect world. Last year, I was having updates come in as late as May, so I think a hard cut off line is prudent.
- 4. New Members/Membership Retention: One thought I had was to try to improve new membership, it would be good to form relationships with the regional club secretaries to see if they feel comfortable sending a flyer or passing along information about BCOA membership. I would imagine if someone has interest in becoming a regional borzoi club member they may be interested in the parent club membership so it's a pretty easy, organic way to get the info out there I think. Perhaps also sending out a flyer for people to put out at their speciality might also be a great way to get interest out.
- 5. I'm still working on maintaining the master membership file as changes come in.

I am pleased to report that I have been able to answer several questions related to the Bylaws and Standing Rules.

One question involved standing rule MMB-1: Clarifcation [sic], the 45 day rule for membership applications: This rule is used only in situations where the minutes with the 1st reading are not sent to the membership on a timely basis. Once the minutes are sent, the clock starts ticking. If no correspondence regarding the applicants is received within 45 days of the publication of the minutes, the membership application is approved.

This rule MMB-1 conflicts with the Bylaws Article 1, Section 4, Paragraph 2: Applicants may be elected for membership in the Club at any meeting of the Board of Directors,

and each application shall be acted upon at the first such meeting to occur after the filing of said application with the Recording Secretary and publication in the official Club minutes.

The Bylaws specify that election to membership occurs at a meeting of the Board of Directors after the filing of a complete application (i.e., said application) and publication in the minutes. There is no provision for automatic election to membership after 45 days, which is implied by MMB-1. My recommendation is that the Board rescind MMB-1 or amend MMB-1 in a manner that removes the conflict with the Bylaws.
