AKC DELEGATE REPORT

November 2023 Prudence G. Hlatky

This report will cover the September 2023 Delegates Meeting and the items of interest for the December 2023 meetings. The minutes from both the June Delegate meeting and the AKC Board of Directors meetings are available on the AKC site. Please take time to read the AKC Secretary's Page in the Gazette to see what changes may have been made in your areas of interest.

Delegate Meeting (September)

Passed Amendment - Voted on at the September Delegate Meeting:

A proposed amendment to the Chapter 2, Section 14, of the Rules Applying to Dog Shows – Dog Show Entries, Conditions of Dogs Affecting Eligibility, inserts "or access to", to recognize the acceptance of digital copies of required booklets at events. . It modifies the list of required

references, removing The Complete Dog Book. It also replaces the list of documents to have available "when applicable" with the generic statement of "any other applicable rules, regulations and/or guidelines for the competitions being held." in recognition of the greatly expanded and changing list of competitions held with Conformation dog shows. Delegate Meeting: Six amendments (September Reading) for voting in December 2023. (See supporting Documents)

Delegate Committee Meetings

Delegate Committee Members Election – of the candidates supported by the BCOA Board, all but two were re-elected.

AKC Parent Club (PC) Items of Interest for BCOA BOD review

Statistics presented: 22 Breeds make up 80% of dogs breed. The next 20 breeds are 10% of the dogs breed. All other breeds are the final 10%. 80% of breeders are casual breeders (one time pet litter). Only 22% of all dogs registered are by PC members. 80% of show dogs are handled by their owners.

As PC Preservation Breeders we need to emphasize the uniqueness of our breed. We need to sell our breeds best features.

Jr Showmanship – emphasis on mentoring Juniors and young adults. Unfortunately, most of them work for handlers. They don't want to breed; they want the excitement of the win. But they are a breed's future. Parent Clubs need to develop a Junior Mentoring Program.

Parent Club Breeder's Development: To be discussed as part of BCOA Member Education Committee Report:

Consists of the following areas of interest:

Breeder Education Coordinator: Committee has developed the Suggested Guidelines for Establishing a Breeder Education Coordinator.

Iconic Breeder Interviews: Parent Club has developed list of questions to be used. Previously provided to BCOA BOD

Mentoring – Current membership, new members, Juniors

EDDY Award: www.akc.org/breeder-programs/breeder-education/akc-eddy-award/ All-Breed Committee –

Legislative Update (Parent Club & All-Breed Committees): The current farm bill, Puppy Protection Act and Goldie's Act which removes the distinction between paperwork and care and conditions. The House Agricultural Committee Staff is being worked with very closely on this. We have good support to be sure and remove any animal rights language from the bill. It is necessary for people to contact their own legislators and let them know that these bills should be opposed. The U.S. Center for Disease Control, which monitors dogs being imported from high-risk countries has a regulation that would prohibit dogs under the age of six months from being imported in. The Legislative department is working with them on alternatives to this, so breeders importing puppies for themselves may continue to do so. There is currently a QR code available which provides certificates for veterinary inspection requirements by state, such as rabies certificates, etc. It allows exhibitor transporting dogs across state lines to be aware of which vaccines are required in each state. This information is very important for clubs to consider including on premium lists.

Herding-Earthdog-Coursing-Scent Work Committee (from the committee minutes)

Lure Coursing Nationals-December 1-3, 2023, in Ardmore, OK. The Trinity Valley Rhodesian Ridgeback Club of TX will be the host club.

Many coursing judges need judging seminars. Prefer online seminars which currently are not available. Judges may not know they need to contact AKC for clubs offering seminars and clubs may not know they need to approach AKC to offer seminars.

Supporting Documents

December 2023 Amendment Votes (with the exception of Chapter 16, Sec 1, these are housekeeping items, not major policy changes)

Article XIII, Section 2, of the Charter and Bylaws of The American Kennel Club, which adds clarity and describes the current practice for a Trial Board notice of charges being filed. Article XIII, Section 7, of the Charter and Bylaws of The American Kennel Club, which removes the italics that do not affect the meaning of the sentence about an appeal of a Trial Board decision.

Article XIV, Section 1, of the Charter and Bylaws of The American Kennel Club, which adds clarity and describes the current practice for an Event Committee suspension by a club or association.

Chapter 11, Section 13, of the Rules Applying to Dog Shows – Dog Show Entries, Conditions of Dogs Affecting Eligibility, removes the reference to sweepstakes and futurity judges from the rule as any restrictions have historically been defined by Board policy. It also replaces the third paragraph of the current rule with a general statement that directs individuals to the Rules, Policies and Guidelines for Conformation Judges for information concerning exhibiting restrictions for sweepstakes, futurity and special attraction judges as they are defined by Board policy.

Chapter 16, Section 1, of the Rules Applying to Dog Shows – Championships, which removes verbiage related to the Parent Club designating one specialty as its National Specialty show as this text was inserted with the amendment to allow Parent Clubs the option to offer a 3-pt. major for Reserve Winners at its National Specialty and it would no longer be relevant for purpose of this section. It replaces Parent Club with breed club and National Specialty with specialty show to reflect the ability for a 3-pt. major to be awarded for Reserve Winners at any specialty show. It

also rearranges text for better understanding and comprehension as well as removes the provision which only applied to the 2021 calendar year.

BCOA BOD has previously instructed the Delegate to vote in favor of this amendment. Chapter 14, Section 29, of the Field Trial Rules and Standard Procedure for Pointing Breeds, which removes the restriction that if the club fails to hold the horseback championship, it may lose the ability to hold the walking championship.

October 2023 Update to Clubs

Modification to Recording and Service Fees for Agility, Conformation, Obedience, and Rally

The recording and service fee structure has been modified for Agility, Conformation, Obedience, and Rally events. The fees for the first entry for each dog are unchanged. The fees for each additional entry for a dog will increase by fifty cents. This change makes the fees for Agility, Conformation, Obedience, and Rally events match the fees that are currently required for performance events.

These changes are effective for events occurring on or after January 1, 2024. The post-event reports for each sport will be modified and included in the event kits for post-January 1, 2024 events and they will be available on the AKC website in mid-December 2023.

Age Limit for Conformation Sweepstakes and Futurities Increased to Up to 24 Months

The age limit for Conformation Sweepstakes and Futurities has been increased from 18 months to up to 24 months of age. Following COVID, the AKC temporarily allowed clubs to hold Sweepstakes and Futurities for dogs up to 24 months of age. Based on the feedback from clubs and the success of their events, the age limit has been permanently increased to up to 24 months of age. The use of the increased age limit is an option for the club. This is effective immediately.

Class Catalog Order for Obedience Trials

The Obedience Regulations will be modified to state that the Regular and Preferred Open and Utility class entries *may* be listed together in the catalog. This will allow the catalog to be consistent with how the class entries are required to be listed in the judging program and the judge's book. This will be effective for Obedience trials on or after January 1, 2024.

Clarification to Junior Showmanship Judging Guidelines

The Junior Showmanship Judging Guidelines have been modified to clarify that the show qualities, including breed standard disqualifications and/or defined faults, of the dog being exhibited are not to be considered when evaluating the junior.

Judging Programs for Multi-Day Events

The Rules Applying to Dog Shows ("Rules"), Chapter 11, Section 6 defines the conditions for which a correction or change of class may be made. For dogs who have completed their championship after the close of entries and are unconfirmed, the transfer must be made with the superintendent/show secretary at least one half-hour prior to the scheduled start of any regular conformation judging at the show. Chapter 11 Section 6 continues to specify that a transfer to Best of Breed/Variety must be made at least one half-hour prior to the start of judging on the first day of the show.

For single shows with multiple days of judging, the first day of a show is the first day on which there is judging for the regular conformation classes with Sweepstakes and Futurities not considered regular conformation classes (*Rules* Chapter 3, Section 2). For most events, the "first day of the show" equates to the day the puppy dogs class, or first class defined in *Rules*, Chapter 3 Section 3 with entries, is scheduled to be judged.

Exactly when a transfer to Best of Breed/Variety must be completed at shows with multiple days of judging has been a source of confusion and misinterpretation for experienced and novice exhibitors. To aid exhibitors and superintendents/show secretaries participating in single events with multiple days of judging, the date and time that all transfers to Best of Breed (or Variety) must be made with the superintendent/show secretary must be published in the judging program. This requirement is effective for events held on or after January 1, 2024.

Example:

All transfers to Best of Breed MUST BE MADE with the Show Secretary by 12:30 PM, Wednesday February 7, 2024.

Judges Panel Management (JPM) Tool Available for Clubs to Manage Their Judges Panels

The new <u>Judges Panel Management</u> (JPM) tool enables clubs to manage the judges panels for multiple events simultaneously and supports the easy and efficient assignment of a judge to multiple classes/breeds/stakes. Since its release in mid-May, we have received overwhelmingly positive feedback from our users. We recommend all user to review the <u>Tips for using the JPM Tool</u> before using the tool. The JPM tool is available within the <u>Online Event Management</u> system.

Information for Clubs Holding FSS Open Shows

Clubs must offer two groups of competition:

- FSS breeds eligible to compete in the Miscellaneous Class
- FSS breeds not eligible to compete in the Miscellaneous Class

Four group placements are available for each of the two groups in FSS Open Shows. There have been instances where clubs/judges have only awarded a Group First for each of the two groups. That is not correct. Based on entries, clubs should be prepared to award up to four group placements for each of these two groups.

The following breed classes must be offered at all FSS Open Shows:

- 4-6 Month Puppy Class
- 6-9 Month Puppy Class
- 9-12 Month Puppy Class
- Bred-By Exhibitor Class
- Open Class

No further division of classes by age is allowed, most notably classes for exhibits 12 months of age or older. Additionally, the consolidation of puppy classes by age is prohibited.

Clubs may elect to divide or combine classes by sex. Division of sexes must be uniformly applied to all breeds and must be published in the premium list.
