DIRECTIONS TO HAGGARD'S RANCH

7655 Rawhide Rd, Celina, TX 75009 GPS does work. From Dallas: Take the Dallas North Tollway NORTH until it officially ends at US Hwy 380 at the north end of Frisco. When the official Tollway ends, CONTINUE STRAIGHT across US 380 on the Tollway Extension (2 lane road.) When the Tollway Extension dead ends at FM 428 in Celina, TURN RIGHT (East) on FM 428. Follow 428 around the curves until it dead ends into FM455. TURN LEFT (west) on FM 455 and continue around the curve about 1 mile and turn LEFT on County RD 9. Go approximately 1/2 mile on RD 9 and turn LEFT onto Rawhide Rd. (Look for the Lure Coursing signs.) Go to the top of the second hill on the right hand side and 7655 on the mailbox. Brick house, red barns, white fence. You're there!

Camping & RV parking is not permitted at the event site.

Early acceptance of hounds for members of the field committee may begin one-half hour prior to published test hours.

ELIGIBILITY

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered hounds are eligible. Monorchid & cryptorchid dogs are NOT eligible. Bitches in-season and lame hounds will be excused and entry fees refunded. Owners may NOT substitute for lame or in- season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

TRIAL STAKES OFFERED

JUNIOR COURSER (JC) & QUALIFIED COURSER (QC) TESTS: Open to all hounds of an eligible breed at least 12 months of age. A hound running alone shall receive one qualification from a judge, and second Qualification from a different judge at a separate event, stating that the hound complete a six hundred (600) yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. **Qualified Courser** hound will run with another hound (Testing Hound). This certification is required to enter a hound in an Open Stake. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course. Additional rules and regulations may be found on the AKC website

OPEN: Open only to hounds of eligible breed, with no breed disqualifications, that hold an AKC QC certificate OR have run in the Open Stake prior to Jan. 1, 2010, OR have a Senior Courser title OR have an ASFA or CKC field champion title. (a copy of this title must be attached to the entry form if the QC requirement is to be waived). Championship points are awarded from this stake. Hounds under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

OPEN VETERAN: Open only to hounds that are eligible to enter either Open or Specials Stake, and are of Veteran age as determined by their Parent Breed Club. Championship or LCX points may be awarded from this stake. Hounds under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

SPECIALS: Open only to hounds that are eligible to enter the Open Stake and have earned their AKC Field Championship title. LCX points may be awarded from this stake. Hounds under disqualification from AKC, ASFA or CKC Field Trials may NOT be entered.

SINGLE: Open to all hounds of eligible breed, including those that are otherwise disqualified from entering the regular stakes (open, specials and veteran). Hounds entering in the singles stake may not also enter a regular stake at the same event. No championship or LCX points are awarded from this stake.
