ELIGIBILITY

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered Borzoi are eligible. Monorchid & cryptorchid dogs are NOT eligible. Owners may substitute a borzoi which they own for a lame or in-season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

TRIAL STAKES OFFERED

JUNIOR COURSER (JC) & QUALIFIED COURSER (QC) TESTS: Open to all Borzoi at least 12 months of age. A Borzoi running alone shall receive one qualification from a judge, and second qualification from a different judge at a separate event, stating that the Borzoi complete a six hundred (600) yard course with a minimum of four (4) turns. The Borzoi must complete the course with enthusiasm and without interruption. **Qualified Courser** Borzoi will run with another Borzoi (Testing Borzoi). This certification is required to enter a Borzoi in an Open Stake. The handler presenting the qualifying Borzoi shall be responsible for providing the Testing Borzoi for the qualifying course. Additional rules and regulations may be found on the AKC website

OPEN: Open only to Borzoi that hold an AKC QC certificate OR have run in the Open Stake prior to Jan. 1, 2010, OR have a Senior Courser title, OR have an ASFA or CKC field champion title (a copy of this title must be attached to the entry form if the QC requirement is to be waived). Championship points are awarded from this stake. Borzoi under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

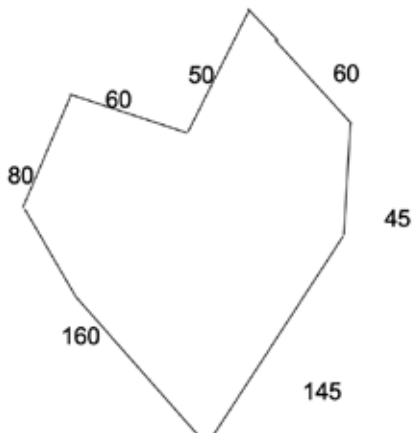
OPEN VETERAN: Open only to Borzoi that are eligible to enter either Open or Specials Stake, and are of Veteran age as determined by their Parent Breed Club. Championship or LCX points may be awarded from this stake. Borzoi under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

SPECIALS: Open only to Borzoi that are eligible to enter the Open Stake and have earned their AKC Field Championship title. LCX points may be awarded from this stake. Borzoi under disqualification from AKC, ASFA or CKC Field Trials may NOT be entered.

SINGLE: Open to all Borzoi of eligible breed, including those that are otherwise disqualified from entering the regular stakes (open, specials and veteran). Borzoi entering in the singles stake may not also enter a regular stake at the same event. No championship or LCX points are awarded from this stake.

TROPHIES: BCOA reserves the right to substitute a trophy of equal or higher value. Trophies and prizes will be awarded in the judging ring to the person exhibiting the dog who will be considered to be the owner or agent of the owner. All claims for trophies and other prizes must be made in the judging ring before the completion of the judging of the breed and the Show Chairperson must be advised at once in the event of any discrepancy. No award will be mailed.

Directions to the field from the show site: (travel time approx. 2 ½ hrs.)

Turn left onto N. 20th Ave. From the right lane, exit and merge onto I-182 E/US-12 E. Exit right onto US-395 N/N Oregon Ave, heading north. Merge onto I-90 E. Take exit #296 from I-90 E. Go north on Harvard Ave. At the light, turn right onto E Wellesley Ave. Turn left onto N Chase Rd. The field is on the left.

Camping & RV parking is permitted at the event site. No hookups. Camping is allowed on the field, available after 4pm Friday, May 31.

FIELD CONDITIONS: Please bring plenty of water and shade.

HOSPITALITY

Morning hospitality will be available. Potluck lunch, Donations are always appreciated. Judges' hospitality provided by Vicki Savage.

- A **\$5.00 fine will be assessed for any Borzoi loose on the field not competing in the course in progress.** There will be a \$50 fine for those who do not pick up after their dogs.
- A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips.

BCOA reserves the right to **alter the course plan** if required by weather and/or field conditions prior to or on the day of the trial, which may affect the usability of the field. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, will forfeit entry fee(s), and may be disciplined by the AKC.
