ELIGIBLE BREEDS AND REGISTRY

Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Norrbottenspets, Peruvian Inca Orchids, Pharaoh Hounds, Portuguese Podengos, Portuguese Podengo Pequenos, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Thai Ridgebacks and Whippets that are one year of age or older, that have been registered with The American Kennel Club, or part of an AKC-registered litter, or otherwise, if whelped outside of the United States of America and owned by a resident of the USA, or of a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an Indefinite Listing Privilege (ILP) or Purebred Alternative Listing (PAL), are eligible to participate in lure coursing tests and trials and be awarded the prefix title of Field Champion and the suffix titles of Junior Courser, Senior Courser or Master Courser. Those sighthounds enrolled in AKC's Foundation Stock Service (FSS) which are eligible to compete in Conformation Miscellaneous class are eligible to compete in lure coursing tests and trials and be awarded the prefix of Field Champion and the suffix titles of Junior Courser, Qualified Courser, Senior Courser or Master Courser.

ELIGIBILITY

Hounds must be one year of age or older on the day of the trial. Hounds not present at the time of roll call will be scratched after a 5-minute grace period. Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test and, in such instances, applicable entry fees will be refunded. At roll call, all hounds will be examined at inspection for breed disqualifications. Bitches in season, lame and unfit dogs will be excused with entry refunded. Please do not bring bitches in season to the test.

Spayed or neutered hounds are eligible to participate. Monorchid and cryptorchid hounds are ineligible to participate. Hounds may not be entered as "registration or ILP pending". Breed disqualifications apply.

RIBBONS & TROPHY

Flat ribbons will be provided for hounds that complete a Qualifying Run.

FIELD CONDITIONS

There is no shade at this field. Bring water and plan to provide shade for your dogs.

Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, will forfeit entry fee(s), and may be disciplined by the AKC. A \$5.00 fine will be assessed for any Borzoi loose on the field not competing in the course in progress. There will be a \$50 fine for those who do not pick up after their dogs.

Travel time is approx. 30 minutes from the host hotel.

GPS/MAP: "99 Glendale Rd., Limestone TN 37681"

Google Maps works well. Verizon has the best cell coverage, but reception on the field may be spotty. There will be signage for the "field entrance."

FROM I-81 (N, E, W) (12 MINS): NEVER USE EXIT 44. Take exit 50 for TN-93 south for 1.8 miles. Continue straight onto TN-81 for 2.2 miles. Right on Cherry Hill Rd for .6 miles. Bear left to Martin Rd. for .9 miles. Right on Glendale for 2.7 miles.

FROM I-26 (S) (40 MINS): Take exit 37 north on TN-107/TN-81 for about 22 miles. Follow signs for TN-81N through Jonesborough. After passing the Marathon, keep an eye out for a sharp right turn, where you'll continue straight onto Pleasant Grove Rd. for .8 miles. Turn right onto Glendale Rd for 3.4 miles.

RV NOTICE: Highly advised that you come in via: I-81 - TN 93 (Exit 50) - TN-81N - Oak Hill Cir (Across from Oak Hill Baptist Church) - Oak Hill Rd - Martin Rd - Glendale Rd

FIELD LOCATION

For the east field, "Talladega," you will enter at the "field entrance" sign. "Talladega" is the first field to the left of the gravel drive.

CAMPING & RV PARKING

Permitted on the field at the event site. No hookups. Camping is available after 4 PM Friday, April 18, 2025. RVs will be able to make it out to the field, in case of loss of traction, a tractor and loader will be on hand for assistance.
