

From the Editor

In Botswana when people greet each other they say: "Dumela." "Dumela, le kae?" "Ke teng. Oena le kae?" "Le nna ke teng."

This conversation is comparable to our, "Hello, How are you?" "I am fine and you?" But it literally translates as "Hello, where are you?" "I am here; where are you?" "And me, I am here." It suggests that being fine is intrinsically tied to a sense of place.

In my little town the old hotel, where William Jennings Bryan stood on a balcony and campaigned for the gold standard, is gone; the Arts and Heritage Building (the town's oldest school building), where the night before Tim had been part of the premiere of a play written by the philosophy professor, where next week the English professor, whose house and car are now destroyed, was to read from his most recent book of poetry, where artists had studios and held openings, is gone; the Community Center next door (another old school house), where some very lucky volleyball players had cancelled their game, is gone. The Catholic Church is destroyed, and the Lutherans across the way fared no better. Of the 2,500 homes in town, 500 were destroyed, 700 were left uninhabitable and 800 had significant but repairable damage. That doesn't count the apartment buildings, the businesses. or the schools. Our college is devastated. Never in the history of America has a college suffered so much damage. I used to love to drive into the valley and see all the spires. There isn't a spire left in town; gone, along with all the other church spires, is the spire on Christ Chapel at Gustavus Adolphus College, gone is the tower on the court house and the old fire hall. Our legislator who had toured Bosnia, said he saw no destruction there like

Your Dog Library

Dog Eat Dog, A Very Human Book About Dogs and Dog Shows, by Jane and Michael Stern Scribner, 1997

his book was written by and for those outside the dog game but it is interest.

ing to see ourselves as others see us. The authors follow a year in the dog show whirl with a Bullmastiff breeder. Along the way we enter the world of professional handlers, experience the joys and disappointments of breeders, and encounter some delightful characters. We share the hype and thrill of Westminster and the intensity of a specialty as we travel the dog show circuit. We nod knowingly at the beautiful conformation dog who is retired because he refuses to strut his stuff and prefers to rule the world from the couch, and we empathize with the breeder with limited resources who must compete against the dog whose picture graces every dog magazine and whose campaign resources know no limit.

There are either personality differences that accompany the owners of various breeds, or else, by selection, I have avoided meeting some of the rude and crude crowd that are depicted here. Although some impolite comments are definitely made and duly reported, in at least one instance

I think the authors misinterpreted one handler's remark to another. The handler in question commented to his opponent that he noticed that he hadn't clipped his nose hairs for this specialty either. The author assumed it was a crack about the human's personal grooming, while I think the other handler was referring to the whiskers on the dog.

The tenseness of ringside is well presented, although the snide remarks stated just loudly enough for all to hear and the bitterness between competitors seems exaggerated. Maybe I have been spoiled by "Minnesota Nice." At every show the judge is labelled a complete ignoramus until he puts up the speaker's dog, which inevitably raises his intellect at least fifty points. But through the reporting of all our peccadillos, there is one thing that comes through and that is the love and



he witnessed in St. Peter. Ours is one of the oldest towns in Minnesota. It was to be the capital, but a renegade legislator from Bemidji stole the bill on the last night of the session. The square which was to house the capital is a huge park now. A park where 80 huge shade trees used to stand. The bleachers where I was to watch my daughter graduate from high school in two months are twisted into some perverse giant slinky toy. In a few minutes a tornado tore the heart

and soul out of our community.

Eighteen thousand trees are gone. We're back to prairie. The town looks like it did 130 years ago. But that's not my town. I want my town back. We're supposed to be thankful—there wasn't a great loss of life, one little blonde, six-year-old boy sucked from his parents van, an older farmer in a neighboring community, but each time I drive to town I am filled with emptiness. At work

the psychiatrists and psychologists email us telling us how to cope, even how to cope with our guilt at not being as bad off as others.

The Key City Kennel Club centered in nearby Mankato usually holds their show on the St. Peter Fairgrounds, now in ruins. The board met to decide on a new site. Three neighboring fairgrounds were offered. Committee members drew up sides depending on their own political agendas. "That's too far for my stewards to drive." "It will be too hard to cart the flowers that far." The one committee member from St. Peter who had lost her house and her grooming business stood up and told them she was leaving if they didn't stop this bickering immediately. She related this story to me at dog show one week after the tragedy. She went to the show after a week of salvaging and dealing with insurance adjusters—to seek normalcy, to laugh, to enjoy her dogs, to be with friends. The

same reasons we all should go to dog activities, not to fight, not to be angry or sad if we don't win or get our own way.

I thought that cancer had pretty well straightened out my priorities for me. But in paring down my priorities I had to be reminded that although my family and friends are most important, you can not underestimate the importance of a sense of place. My life was entwined with those buildings and those who lived, played, and
