The Top Open Field Coursing Borzoi for 2005 is Follyqtrs' Svetlana Zoyanova, **Svetlana**, owned and bred by Margaret Rice. During her first season of competition, which started this fall, she defeated 62 Borzoi. In addition, Svetlana was the overall winner of the Borzoi Fall Classic, which had an entry of 26 this year. The only Borzoi to earn her open field title during the year was FC Rassim's Domroeschen at Téine, NACM, NACC, **Daru**, owned by Anne Midgarden. She, too, started her coursing career in October and won the first three breed hunts she entered. Over fifty Borzoi competed in open field coursing this year. The majority of them were owned by BCOA members.
