Borzoi History

Borzoi Points.

To the Editor of the STOCK-KEEPER.

SIR,-May "Highland" reply to your comments on his article on Mr. Hacke's Borzois, as appeared in your issue of October 2? If so, permit me to say that "Petie" Michaelovitch is not to sell his stock of Borzois, so I am informed, and Mr. Hacke will have to look elsewhere for new recruits, laus Deo, as we have enough to be thankful (!) for in what already has come from "Georgy Porgey" Michaelovitch. Such stock is not what is wanted, and I so stated it.

Job lots, as a rule, are no good. Better one good one, like Armeda, than the eight others. She, I should say, is worth the whole catalogue.

Permit me to say I cannot recede from my position, that "the objection of some of the English judges to the slightest appearance of the late is the supported with the slightest appearance of the sl English judges to the slightest appearance of black is to us supremely ridiculous, and wholly founded on prejudice." I hope you will not think me either pedantic or asinine if I attempt to state my convictions, nor arrogant if I argue the point. The Russian standard, in my eyes, is a farce, inasmuch as it makes the value of the eye and ear equal to ribs and back, and the tail of equal importance with the forelegs. On what sort of reasoning can such a standard ever be considered as worth one ran? That in itself stamps the Russian, in my rap? That in itself stamps the Russian, in my mind, as wholly incapable of properly judging a dog which is for coursing, and of whom they say, "the main things are the working points." What "working points" are there about the eyes and ears that will give them ten points, and the same number of points be given to ribs and back? If Colonel Tschipoints be given to rios and back? If Colonel Ischibishoff is an authority on Borzois, and disqualifies black, why does he not have the Russian Imperial Society incorporate it into their "points," and why does that society fail to speak of it, or allude to it in any way? And I would also ask, on what he bases the statement that black is now, dorson indicates a descent from English or in any degree indicates a descent from English or Oriental Greyhounds. There are as many brindles Oriental Greyhounds. There are as many brindles as there are blacks, there are nearly as many fawns as blues, and whites as reds, and consequently I am utterly at a loss to see the force of the argument. If all Greyhounds were black, then his ground might be tenable, but they are not. I believe in reasoning, not actenable, but they are not. I believe in reasoning, not accepting in blind faith what is spoken. If Colonel Tschibishoff will advance another theory why black should disqualify, I'll be glad to hear it. The Borzoi truly is a dog comparatively new to us all, yet that is no reason why, when we once know its uses, we should go on breeding it as it has been bred for generations, go on breeding it as it has been bred for generations, simply because the specimens we see are of the traditional sort. I hate traditions. Take for instance the St. Bernards of thirty years ago. The Swiss, no doubt, were as jealous of their accredited doggy wisdom as the Russians are, yet who would be so stupid as to wish to return to the old St. Berhe so stupid as to wish to return to the old St. Bernard anterior to old Barry's time, and throw overboard Sir Bedivere, Alton, Prince Regent, etc. To whom is the credit of the great improvement in this breed due? "To the English, solely and purely, and so it is. I feel sure if the Borzoi judges of to-day will ignore the standard and the foolish prejudices of the Russians and breed the dog on scientific principle; it will soon produce as much finer specimens as ples it will soon produce as much finer specimens as now seen, as the Hector of to-day is superior to his great great granddam. If you are going to consider, "the main things are the working consider, points, " points," you have got perfore, to discard the question of black disqualifying, else your mission will be half fulfilled, and if you are striving to make ears and eyes of equal value with backs and ribs, you'll make a perfect mull of it. Intelligence against prejudice will ever win.

Again. The Imperial Standard calls for "somewhat narrow chest." If you are breeding a dog for speed and endurance, where in the name of commonsense are you going to get heart and lung room with a "somewhat narrow chest" and "flat ribs like a fish"! Where is the heart to have room to beat and fish "! Where is the heart to have room to beat and the lungs to expand with such a conformation? Will a flat-sided Greyhound or Foxhound or hunter stay from start to fluish with such a figure? On what principle of philosophy does "the hind legs, the least thing under the body, and the stifle only slightly bent," give he dog an advantage over one whose hind legs are et well back, stifles well bent, and hocks low set? Taking any racing animal, and prove that such shape conduces to speed. What, too, is the principle on which a dog, whose body and legs "describes a square," has within himself more speed and endurance than one who better describes a sort of rectangle? I have made a study of mechanics, but this is a poser

Another very strong feature which the Russian ignores is the head. If there is anything that shows type, character, breeding, and force, whether it be in man or beast, it is the head, and the fact that this feature is ignored only confirms my belief of the Russian's incapability to judge his native dogs properly. For instance, takeMr. Hacke's Osmaday. If there ever was a Collie head on a dog Osmaday has one. Will the Russian say this quality is of no value in judging, and that all things else being equal with Oosslad, or Korotai, or Krilutt, Osmaday would press any of the others for first prize? Yet such is stated boldly since there is no value placed on the head.

I have a letter from a gentleman in England, who is considered an authority on Borzois, who says he would be very chary about breeding a bitch to a dog with black on it. You have two dogs on your side, brothers, viz., Argos and Oosslad. The dam and sire are white-and-orange. Argos is white-and-black, Oosslad is white-and-orange. The latter is many times a winner, and is considered one of the best in England. As both had the same parents, will your breeders throw Argos over and take Oosslad, because the former has somewhat of black, the latter none of it? Is not one as likely to throw black-and-white pups as the other? Yet I see Oosslad is advertised at the stud, and Argos is not. It is true Mr. Krehl did give Argos a prize; but was it not third? An authority not long since wrote me: "No one could have grumbled had Argos won first instead of third, excepting but for his having black"; and I am told in point of structural formation he is better than either first or second, both of which are wrong in legs and feet, the one out at elbows, the other wrong on pasterns, hind and fore feet. I am willing to accept any standard that is based on sound common sense, but the Russians I cannot accept. I hope the English will give us as good a one as they have given the St. Bernards, and that they carry seen also irremerable damage will be that, too, very soon, else irreparable damage will be


